Notice is given in terms of Regulation 56(2)(c)(i) of the regulations published in Government Notice No. R. 385 in Government Gazette No. 28573 of 21 April 2006 under the National Environmental Management Act (Act No. 107 of 1998) of intent to carry out the following activity:

The proponent, SANParks intends to develop the Agulhas Lighthouse Precinct, with the main aim to be more visitor friendly: Agulhas National Park, L'Agulhas, Western Cape Province.

The development will include inter alia:
Landscaping; provision of services (water,electricity,sewer); offices for Park Management, Telkom and Portnet; restaurant, vendor stalls; cultural center; picnic -and parking area, translocation of masts and communication equipment, upgrading of existing roads and associated activities.

The activities listed in Regulation R386 of 21 April 2006 –

(1) The construction of facilities or infrastructure, including associated structures or infrastructure, for-

(d) resorts, lodges hotels or other tourism and hospitality facilities in a protected area contemplated in the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003)

(14) The construction of masts of any material or type and of any height, including those used for telecommunication broadcasting and radio transmission, but excluding -

*masts of 15 metres and lower exclusively used
by radio amateurs; or
for lighting purposes
flag poles; and
lightning conductor poles.*

(15) The construction of a road that is wider than 4 metres or that has a reserve wider than 6 metres, excluding roads that fall within the ambit of another listed activity or which are access roads of less than 30 metres long.

A public consultation process forms an integral component of this EIA process.

You are kindly requested to complete the comments form and give any comment/concern or input with regard to the environment that you may have, on the proposed development. If we do not receive any comments from you within 30 days we will accept that you do not have any objections against the project.
