- Limited Entry - 12 FREE entries per year restricted to the following pay points: The Cape of Good Hope (Cape Point), Boulders Penguin Colony, Oudekraal and Silvermine, as well as the use of the braai and picnic areas at Tokai, Newlands and Perdekloof.
- Cards may not be used in lieu of daily conservation fees when using TMNP accommodation.
- Persons wanting to undertake any of the following activities: Dog walking, hang and paragliding, sport climbing, horse riding, mountain biking, line fishing (including the associated movement and introduction of line fish through a national park for recreational purposes) must purchase a My Activity Permit.
- Only persons aged 18 and over may purchase this card.
- 2 x ID photographs are required when purchasing a My Green Card.
- Printed proof of Cape Town residence no older than 3 months.
- The card owner may bring along friends/ family - (a maximum of 5 SA citizens). Proof of identity required for the adults. The Card Holder plus each person who enters with them on the My Green Card is clipped as entry off the card (excluding children under the age of 2).
- At all times one of the adults has to be the Card Owner. Proof of South African identity required for the adults on entry.
- An individual can only buy one My Green Card per year.
- Once the 12 entries are used up you cannot purchase another My Green Card until the expiry date on the card is reached. You do have the option to purchase a SANParks Wild Card or pay the entry fees at the gate.
- Cards are not transferable or replaceable if lost or stolen.
- SANParks entry is subject to visitor capacity and gate entry times.
- Prices and terms of use are subject to change without notice.
- Any misuse of the card, misconduct or illegal activities will result in immediate confiscation of the card and applicable legal ramifications will follow.
- The My Green Card may not be used for commercial gain eg. events and tour guides.
- Persons wanting to undertake the removal of west coast rock lobster need to purchase a Marine Species Access Permit in order to carry out this activity. Alternatively they can pay for full entry at the gate and buy a daily Marine Species Access Permit. A My Green Card and SANParks Wild Card cannot be used to gain access to the COGH section of TMNP to carry out this activity.

I acknowledge that all visitors are subject to the conditions set in terms of Section 86 of the National Environmental Management Act (107 of 1998) and the National Environmental Act: Protected Areas Act (Act 57 of 2003) for the duration of their stay in the National Park.
