- Level 1 Dog Walking (maximum x 2 dogs)
- Level 1 Additional Member Dog Walking
- Level 2 Hang- and Paragliding, Sport/Rock Climbing
- Level 3 Horse Riding (maximum x 1 horse), Mountain Biking, Line Fishing (including the associated movement and introduction of line fish through a national park for recreational purposes)

- At pay point areas where daily conservation fees are applicable, a My Activity Permit holder will only be allowed access for the purposes of undertaking the specified recreational activity. If a My Activity Permit holder is accessing a pay point area for leisure (not for the specified recreational activity) purposes, normal daily conservation fees apply. Alternatively, a TMNP My Green Card or SANParks Wild Card may be presented.
- Guardians may purchase a My Activity Permit for their children but the Guardian must sign the conditions of the permit. The Child's photo and ID number must appear on the My Activity Permit.
- Any person under 12 years old must have a guardian /adult accompanying them when they undertake the permitted recreational activity.
- Permits are not transferable.
- If lost or stolen permits are replaceable up to the original permits expiry date: based on production of a receipt of purchase for the original permit, an ID photo and an admin fee.
- SANParks entry is subject to visitor capacity and gate entry times.
- Prices and terms of use are subject to change without notice.
- Any misuse of the permit, misconduct or illegal activities will result in immediate confiscation and applicable legal ramifications will follow.
- My Activity Permit holders may only undertake their permitted recreational activity in areas designated for this purpose as per the relevant Environmental Management Programmes.
- Level 1, 2 and 3 are not included in the SANParks Wild Card or My Green Card.
- X 2 ID photographs and a valid form of identification are required when purchasing an activity permit.
- My Activity Permits are available for purchase to all visitors to Table Mountain National Park.
- The My Activity Permit may not be used for commercial gain.
- My Activity Permit holders may not undertake more than one recreational activity at a time.
- The My Activity Permit is valid for 12 months from date of issue.
- Permits must be available upon request for presentation.

I hereby agree to the marking of the chosen activity permit and acknowledge that its use is subject to all laws, rules and policies applicable to SANParks. I confirm that I know and understand the related Environmental Management Programmes (EMP) and that I will comply fully with the code of conduct, provisions, rules and staff's instructions related to my activity stated therein. **All EMP's are available** on request at Table Mountain National Park offices or online at [www.tmntp.co.za](http://www.tmntp.co.za).

I acknowledge that the areas under the control of SANParks are used entirely at my own risk and SANParks shall not be liable for any claims, accidents, injuries or loss, etc. arising from such use.

I acknowledge that all visitors are subject to the conditions set in terms of Section 86 of the National Environmental Management Act (107 of 1998) and the National Environmental Act: Protected Areas Act (Act 57 of 2003) for the duration of their stay in the National Park.
