#### INVITATION TO PARTICIPATE

Notice is given in terms of Regulation 56 of the Environmental Impact Regulations published in Government Notice R385 in Government Gazette No. 28753 of 21 April 2006, under Section 24(5) of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended, that **Cradle of Malalane (Pty) Ltd** proposes to establish a 240 bed Hotel with associated uses such as a Conference Venue & Spa at the confluence of the Timfene and Crocodile Rivers north east of the Malalane Gate within the Kruger National Park. The development proposal also entails the realignment of Rhenosterkoppies Road which currently traverses the proposed development area.

<b>GNR 386 Item (1)(n)</b>	The off-stream storage of water, including dams and reservoirs, with a capacity of 50 000 cubic metres or more, unless such storage falls within the ambit of the activity listed in item 6 of Government Notice No R387 of 2006
<b>GNR 386 Item (12)</b>	The transformation or removal of indigenous vegetation of 3 hectares or more or of any size where the transformation or removal would occur within a critically endangered ecosystem listed in terms of Section 52 of the National Environmental Management Biodiversity Act, 2004 (Act No 10 of 2004)
<b>GNR 386 Item (13)</b>	The abstraction of groundwater at a volume where any general authorization issued in terms of the National Water Act, 1998 (Act No 36 of 1998) will be exceeded
<b>GNR 386 Item (15)</b>	The construction of a road that is wider than 4 metres and that has a road reserve wider than 6 metres, excluding roads that fall within the ambit of another listed activity or which are access roads of less than 30 metres long
<b>GNR 387 Item (2)</b>	Any development activity, including associated structures and infrastructure, where the total area of the developed area is, or is intended to be 20 hectares or more
