Bidders who meet the requirements of the mandatory phase of evaluation will proceed to the next phase of Presentation Evaluation Phase (Site Visit)

PRESENTATION EVALUATION PHASE (SITE VISIT)

SANParks will conduct site visits with bidders who meet the functionality phase criteria, whereby bidders will present further information or provide further proof to the evaluation committee. Bidders will be evaluated on the below criteria and bidders who meet the below requirements will progress to the next phase of evaluation of price and preference.

1. Demonstrate proof of maximum service capacity processed within a 24 hour period.
2. Demonstrate proof of vehicles with a minimum carrying capacity of 1 ton for delivery and collection of linen (must be available at/upon site visit)

THE BIDDING SELECTION PROCESS

Phase 1 – Compliance to minimum administrative documents

Bidders warrant that their proposal document has, as a minimum, the specified documents required for evaluating their proposals as set out in the Returnable Document List.

Phase 2A – Compliance with mandatory requirements

1. In this phase bid responses are verified against the set of mandatory requirements. Bidders who fail to comply with the requirements may not proceed to the next phase of evaluation.

Phase 2B – Compliance with functionality requirements

Bidders making the minimum evaluation score (70%) will pass to the price/preference stage.

Phase 2C – Compliance with Presentation(Site Visit)

Bidders who comply and meet the functionality threshold of 70%, will proceed to the presentation phase whereby site visits will be conducted and bidders will be measured accordingly in terms of the criteria stipulated in the bid.

Phase 3 – Price/Preference Evaluation

Basis of competition and due diligence tests for reasonableness of price:

SANParks compares each bidder's pricing proposal on an equal and fair comparison basis that is equitable to all bidders taking into account all aspects of the bids pricing requirements.

SANParks conducts fair market-related pricing tests to arrive at an opinion of reasonableness of the bid price offered.

Where these due diligence tests reflect defective pricing or pricing outside of the fair market-related price range, the evaluators will recommend price negotiation with the winning bidder to bring the price within the fair market-related price range as tested.

Where the winning bidder does not want to participate in the price negotiation or provide a fair market-related price, SANParks cancels the award and commences price negotiations with the second bidder in the price/preference ranking.

Ranking of the bidders pricing:

SANParks ranks the qualifying bids on price and preference points claimed in the following manner:

Price – for bids qualifying for this stage, the lowest priced Bid receives the highest price score as set out in the Preferential Procurement Regulations of 2017;

Preference - for bids qualifying for this stage, addition of the claimed preference points in the preference claim form (SBD6.1) where supported by a valid BBBEE certification to the price ranking scores.

Award recommendation:

SANParks nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

SANParks reserves the right not to award to the highest points scorer in accordance with S 2(1) (f) of the Act (PPPFA).

Due Diligence Phase

Where circumstances justifies it, SANParks reserves the right to conduct due diligence (interviews, presentations, site visits) with shortlisted bidders who meet the minimum qualifying score on the functionality phase evaluation criteria, whereby bidders will present further information or provide further proof to the evaluation committee. In these cases, SANParks may provide the areas of concern to the short listed bidders to address in their presentations. Bidders will be evaluated on the below criteria and bidders who meet the below requirements will progress to the next phase of evaluation of price and preference.

BID PROCEDURE CONDITIONS:

Counter Conditions

SANParks draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

Response Preparation Costs

SANParks is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

Cancellation Prior To Awarding

SANParks reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range (in terms of the Preferential Procurement Regulations of 2017), or any process impropriety.

Collusion, Fraud And Corruption

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

Fronting

SANParks, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should SANParks establish any of the fronting indicators as contained in the Department of Trade and Industry's "Guidelines on Complex Structures and Transactions and Fronting" during such inquiry/investigation, the onus is on the bidder to prove that fronting does not exist? Failure to do so within a period of 7 days from date of notification will invalidate the bid/contract and may also result in the restriction of the bidder to conduct business with the public sector for a period not exceeding 10 years, in addition to any other remedies SANParks may have against the bidder concerned.

INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System.

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

INTRODUCTION TO SANPARKS BUSINESS UNIT RESPONSIBLE FOR THIS BID

The Tsitsikamma section of the Garden Route National Park is situated at the heart of the Garden Route. The park covers an 80 kilometers long stretch of coastline. Nature's Valley is at the Western end of the park (Western Cape, closest town is Plettenberg Bay), and the main accommodation is at Storms River Mouth (Eastern Cape, closest town is Humansdorp).

CONTEXT OF THIS PROCUREMENT

The purpose of this bid is to invite prospective bidders to submit a proposal on the provision of laundry services to the Stormsriver Mouth Rest Camp, Tsitsikamma and De Vasselot Rest Camp, Nature's Valley.

CONTRACT PERIOD

The period of this contract is five (5) years.

COLLECTION AND DELIVERY OF LINEN

- Linen to be collected and delivered by the Service Provider.
- All linen previously collected for cleaning must be delivered in total upon the next collection of dirty linen or upon special request.

STORM RIVER MOUTH MAIN CAMP

- Daily delivering and collection at 12:00.
- The Service Provider may also be requested to, from time to time do ad hoc deliveries on short notice.

NATURES VALLEY CAMP

- Daily delivering and collection at 12:00
- The Service Provider may also be requested to, from time to time do ad hoc deliveries on short notice.

REQUIREMENTS

- List of cleaning products to be used for the cleaning of the linen and proof that they are SABS compliant must

be provided together with this bid

- Proof that the cleaning products adhere to required Health and Safety Regulations.
- List of current and previous clients for reference purposes.

RESPONSIBILITIES OF SANPARKS

- SANParks reserves the right to conduct a site visit as part of the evaluation process.
- Upon the site visit, the bidder must be able to present their capacity necessary to fulfil the required service (machinery – output per hour, staff and schedules).
- When the need arises, conduct a performance review to the attention of the company's management for improvement and expect feedback on how such, if any, unsatisfactory performance or bad behaviour will be prevented for future occurrences.
- Hold quarterly meetings with successful bidder to discuss any issues arising (progress or unsatisfactory performance), if and when required
- Effecting payment of invoices according to the requirement of the PFMA.
- SANParks reserves the right to return any linen not cleaned according to their standards. Costs of this will be for the account of the Service Provider.
- Discrepancies and shortages must be reported and negotiated within 24hrs
- The contractor will be notified in writing of sub-standard services.
- SANParks reserves the right to terminate the contract should sub-standard services continue.

RESPONSIBILITIES OF THE BIDDER

- Discrepancies and shortages must be reported and negotiated within 24hrs.
- To invoice SANParks once a month.
- Linen must be transported in sealed containers to prevent contamination.
- Bidders must show infrastructure and deployment plan to be able to provide Laundry Services. The workplace must comply with all the set Regulations under the Health and Safety Act.
- The successful bidder must be readily available to render services upon commencement date
- The bidder must be knowledgeable of Hospitality infection control protocols (i.e. stains, such as rust, blood and mildew)
- Items damaged due to the Service Provider's negligence and any losses incurred once linen has left SANParks site will be replaced at the Service Provider's costs within 7 days.
- Where it is not possible for stains to be removed, the Service Provider must bring this to the attention of the Hospitality Services Manager and/ or Duty Managers, in writing within 48 hours of the occurrence.
- Linen that needs special treatment such as dry cleaning must be cleaned accordingly (i.e. curtains)
- Linen must be well presented when delivered i.e. ironed and folded.
- All issues regarding this contract are to be communicated in writing with the Hospitality Services Manager – Tsitsikamma
- No sub-contracting is allowed without express authorization of SANParks.

SPECIAL CONDITIONS OF CONTRACT

- The bidder must submit proof that reasonable arrangement have been made to compensate SANParks for any loss that SANParks may suffer while linen is in possession of the Service provider. Public Liability cover of R 500 000.00 or more must be adjusted to fully cover the risk exposure once appointed

CLEANING STANDARDS

- The Service Provider to provide good quality laundry bags for soiled and clean linen. The bag must have proper closing mechanism. Bags for soiled linen to be clearly marked (permanent labelling or colouring).
- The laundry bags must be properly sealed to avoid loss and the seal number be recorded by both the Service Provider and SANParks.
- For control purpose packing slips must be placed inside the laundry bags, this applies to both soiled and clean linen.
- Provide transparent laundry bags for stained linen (e.g. linen with blood stains). The size of the bag will be specified after the bid is awarded.
- Washing of all linen must be done at the correct temperature using the right detergent to remove blood and other stains.
- Linen must be disinfected during the washing process, in order to ensure that it conforms with high Health and Safety requirements (SANS 10146:2012)

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
