## **RETURNABLE DOCUMENTS**

### **COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS**

#### **(Standard Bidding Documents)**

The verification during this stage is to review bid responses for purposes of assessing compliance with RFB requirements, whereby a bidder may be disqualified if they do not fully comply, which requirements include the following:

1. Invitation to Bid (SBD 1) must be fully completed and signed
2. Submission of fully completed Pricing Schedule (SBD 3.1: Firm Unit Prices).

### **MANDATORY EVALUATION CRITERIA**

#### **(mandatory returnable documents)**

A bidder may be disqualified if they do not fully comply with all mandatory requirements as stipulated below:

1. The bidder shall provide evidence of having been active in the market and supplying the proposed items for a minimum period of 18 months. As proof the bidder shall provide copies of company registration documents.
2. Where the bidder wishes to include in the proposal the supply of any scheduled (1 to 6) veterinary drugs, the bidder shall provide proof of current registration as a pharmacy with the South African Pharmacy Council (SAPC). This proof should include:
  - Proof registration as a pharmacy from the SAPC
  - Pharmacy license number / account number
  - Details of responsible pharmacist including personal registration number

## CENTRAL SUPPLIER DATABASE INFORMATION

Bidders are required to be registered on the Central Supplier Database (CSD) of National Treasury. Failure to submit the requested information may lead to disqualification. (Please provide proof of registration on the Central Supplier Database).

## EVALUATION PHASES

### Phase 1 – Compliance and Governance verification:

The verification during this stage is to review bid responses for purposes of assessing compliance with RFB requirements, whereby a bidder may be disqualified if they do not fully comply

### Phase 2 – Pre-Qualifying Criteria

SANParks invites bidders who are in terms of Regulation 4 of the 2017 Preferential Procurement Regulations (PPR), B-BBEE contributor status **level of 1 – LEVEL 4**.

**NB. A tender that fails to meet this pre-qualifying criteria will be declared an unacceptable tender. [A bidder must have a valid B-BBEE verification document (Affidavit or Certificate) in order to be considered in this regard].**

### Phase 3- Mandatory evaluation criteria

The bidder must indicate its compliance / non-compliance to the requirements and should substantiate its response with supporting evidence. If more space is required to justify compliance, please ensure that the substantiation is clearly cross-referenced to the relevant requirement.

Failure to comply with Mandatory Requirements may lead to the bidder being disqualified, and not considered for further evaluation on the Price and Preference requirements.

Phase 4 – Pricing Requirements

Though the bid is expected to not exceed R 50 000 000.00 in terms of PPPFA and Preferential Procurement Regulations 2017, the use of the 80/20 preferential point systems for Price and B-BBEE will **NOT** be applicable whereby the bidder who scored the highest points is recommended for award because SANParks is looking to appoint a **Panel** of service providers and not an individual company.

Therefore bidders will not be recommended for award based on those who were the cheapest, there will be various aspects taken into account with regards to the recommendation, such as the mandatory requirements stipulated above and the fact that SANParks requires a panel. Those that meet the mandatory requirements for each requirement stated above will be recommended for the panel.

Phase 5 – Due Diligence Phase

Where circumstances justifies it, SANParks reserves the right to conduct due diligence (interviews, presentations, site visits) with shortlisted bidders who meet the requirements for mandatory evaluation whereby bidders will present further information or provide further proof to the evaluation committee. In these cases, SANParks may provide the areas of concern to the short listed bidders to address in their presentations. Bidders will be evaluated on the below criteria and bidders who meet the below requirements will progress to the next phase of evaluation of price.

**BID PROCEDURE CONDITIONS:**

**Counter Conditions**

SANParks draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

**Response Preparation Costs**

SANParks is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

**Cancellation Prior To Awarding**

SANParks reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range (in terms of the Preferential Procurement Regulations of 2017), or any process impropriety.

**Collusion, Fraud And Corruption**

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

**Fronting**

SANParks, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should SANParks establish any of the fronting indicators as contained in the Department of Trade and Industry’s “Guidelines on Complex Structures and Transactions and Fronting” during such inquiry/investigation, the onus is on the bidder to prove that fronting does not exist? Failure to do so within a period of 7 days from date of notification will invalidate the bid/contract and may also result in the restriction of the bidder to conduct business with the public sector for a period not exceeding 10 years, in addition to any other remedies SANParks may have against the bidder concerned.

The department has bases in two locations, Skukuza (Mpumalanga Province) and Kimberly (Northern Cape Province) and teams based at these two offices are responsible for veterinary work across the entire national parks system in South Africa. The department maintains an extensive bank of biological samples (Biobank), obtained from wild animals in the national parks, which functions in support of the various research projects being undertaken on wildlife in the national parks.

## **CONTEXT OF THIS PROCUREMENT**

The Veterinary Wildlife Services department wishes to appoint suitable suppliers to supply capture and treatment drugs, veterinary consumables, vaccines and disinfectants to the department for use on wildlife and in the facilities managed by the department. The listed items will be requested on an as-required basis and should be supplied upon the receipt of an official purchase order. Purchase orders will be accompanied by a prescription, signed by one of the departmental veterinarians, for any scheduled 2 to 6 drugs included on the purchase order.
