1. PURPOSE

The purpose of this exercise is to appoint a service provide to **install a perimeter of 2400mm diamond mesh fence, of 2400mm high and 8 wire electric fence on top of the diamond mesh in Skukuza Rest camp between from Wild fig guest house to unit 208 river view side.**

2. BACKGROUND

South African National Parks (Sparks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, Sparks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*.

Sparks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

SCOPE OF WORK

The Sanparks Technical Services department is looking to appoint a service provider to do the following fence project.

Site clearance , taking down and removal of the existing 1500mm high diamond with electric fence including concrete bases.

Install a perimeter of 2.4mm diamond mesh fence, of 2400mm high and 6 wire electric fence on top of the diamond mesh to include posts, concrete bases, strands, barb wire, etc. A 300 x 300mm Concrete base to bottom of fence including excavation, formwork and reinforcing bar.

The disposal of the old concrete bases and diamond mesh must be done to a licenced disposal area. outside the park. Transport and disposal fee will be payable by the service provider.
