Preference - for bids qualifying for this stage, the bidder will be awarded the preference points claimed in the preference claim form (SBD6.1) and supported by a valid BBEE certification or sworn affidavit.

Award recommendation:

SANParks nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

Counter Conditions

SANParks draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a sustainable National Park System connecting society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System.

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

INTRODUCTION TO SANPARKS BUSINESS UNIT RESPONSIBLE FOR THIS BID

Under the authority of SANParks; the world-renowned Kruger National Park (KNP); is unrivalled in the diversity of its life forms and a world leader in advanced environmental management techniques and policies. As the flagship of SANParks – KNP represents the cultures, persons and events of the region historically and is conserved along with the park's natural assets. Established in 1898 to protect the wildlife of the South African Lowveld, and opening its gates to the public in 1927, KNP has become a major research and conservation centre and one of Africa's premier wildlife-watching destinations. As the largest National Park in South Africa, the KNP spans 19,485 square km and extends approximately 453 km from North to South and 60 km from East to West. Being a narrow wedge in orientation; KNP is bordered by Mozambique to the East; Limpopo Province to the West and Mpumalanga Province to the West and South. Rimming the Park to the West, and sharing the same unfenced terrain, is a chain of private wildlife reserves.

CONTEXT OF THIS PROCUREMENT

The Kruger National Park intends to appoint a credible supplier for the supply and delivery of boiler coal for SANParks as and when required for the period of five (5) years with the option of renewing.

CONTRACT PERIOD

The contract period is **Five (05)** years commencing from the last signature date on the signature page for the supply and delivery of boiler coal contract and the last service provided as and when required.

SPECIFICATIONS

CONDITIONS

- All goods or services purchased will be subjected to South African National Parks Conditions of Contract;
- The bidders will be expected to present a proof of specification for the supplied coal grade from the mine on each delivery.
- Penalty Clause (supply and delivery of boiler coal): The period of one week from the time of purchase order receipt by the supplier to delivery will be allowed of which any delays beyond that, penalties will apply.
- Penalty Clause (Supply and delivery of inferior quality boiler coal): If the quality of the delivered boiler coal is inferior to grade A PEAS coal, penalties may be applied.
- All staff will be subject to integrity testing as and when required

SCOPE OF WORK

The contract is for the supply and delivery of boiler coal **[as and when required]** for a period of five (05) years in the Kruger National Park. The quality of the supplied boiler coal shall be grade A PEAS coal as certified by an accredited laboratory, with following specifications that assures minimum ash and moisture content thus increasing boiler efficiency.

SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

- 1.6. **"Country of origin"** means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. **"Day"** means calendar day.
- 1.8. **"Delivery"** means delivery in compliance of the conditions of the contract or order.
- 1.9. **"Delivery ex stock"** means immediate delivery directly from stock actually on hand.
- 1.10. **"Delivery into consignees store or to his site"** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges
