THE BIDDING SELECTION PROCESS

Stage 1 – Compliance to submission requirements

Bidders warrant that their proposal document has, as a minimum, the specified documents required for evaluating their proposals as set out in the Returnable Document List.

SANParks evaluates only procurement responses that are 100% acceptable in terms of the Returnable Document List and mandatory requirements and may disqualify non-acceptable responses for Stage 2.

Stage 2 – Price/Preference Evaluation

Basis of competition:

SANParks compares each bidder’s pricing proposal **offered on the SBD 1**. A bidder who did not make an offer on the SBD1 when submitting their bid at the closing date and time will automatically be disqualified.

Due diligence tests for reasonableness of price:

SANParks conducts fair market-related pricing tests to arrive at an opinion of reasonableness of the preferred bidder’s price offered. Where these tests reflect defective pricing or pricing outside of the fair market-related price range, the bid evaluation committee will recommend to the bid adjudication committee that the preferred bidder be appointed subject to negotiation in respect of bringing the price within the fair market-related price range as tested.

Where the preferred bidder does not want to participate in the price negotiation or provide a fair market-related price, SANParks will cancel the award and commence price negotiations with the second preferred bidder.

Ranking of the bidders pricing:

SANParks ranks the qualifying bids on price and preference points claimed in the following manner:

Price – for bids qualifying for this stage, the lowest priced Bid receives the highest price score as set out in the Preferential Procurement Policy Regulations of 2017;

Preference - for bids qualifying for this stage, the bidder will be awarded the preference points claimed in the preference claim form (SBD6.1) and supported by a valid BBEE certification or sworn affidavit.

Award recommendation:

SANParks nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

BID PROCEDURE CONDITIONS:

Counter Conditions

SANParks draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

Response Preparation Costs

SANParks is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

Cancellation Prior To Awarding

SANParks reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range (in terms of the Preferential Procurement Policy Framework Act 2017 Regulations), or any process impropriety.

Collusion, Fraud And Corruption

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

Fronting

SANParks, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should SANParks establish any of the fronting indicators as contained in the Department of Trade and Industry’s “Guidelines on Complex Structures and Transactions and Fronting” during such inquiry/investigation, the onus is on the bidder to prove that fronting does not exist? Failure to do so within a period of 7 days from date of notification will invalidate the bid/contract and may also result in the restriction of the bidder to conduct business with the public sector for a period not exceeding 10 years, in addition to any other remedies SANParks may have against the bidder concerned.

INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a sustainable National Park System connecting society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System.

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

INTRODUCTION TO SANPARKS BUSINESS UNIT RESPONSIBLE FOR THIS BID

Under the authority of SANParks; the world-renowned Kruger National Park (KNP); is unrivalled in the diversity of its life forms and a world leader in advanced environmental management techniques and policies. As the flagship of SANParks – KNP represents the cultures, persons and events of the region historically and is conserved along with the park's natural assets. Established in 1898 to protect the wildlife of the South African Lowveld, and opening its gates to the public in 1927, KNP has become a major research and conservation centre and one of Africa's premier wildlife-watching destinations. As the largest National Park in South Africa, the KNP spans 19,485 square km and extends approximately 453 km from North to South and 60 km from East to West. Being a narrow wedge in orientation; KNP is bordered by Mozambique to the East; Limpopo Province to the West and Mpumalanga Province to the West and South. Rimming the Park to the West, and sharing the same unfenced terrain, is a chain of private wildlife reserves.

CONTEXT OF THIS PROCUREMENT

The Kruger National Park intends to appoint a credible service provider to service diesel generators in the Kruger National Park as and when required for the period of five (5) years with the option of renewing.

CONTRACT PERIOD

The contract period is **Five (05)** years commencing from the last signature date on the signature page for the servicing of diesel generators contract and the last service provided as and when required.

SPECIFICATIONS

CONDITIONS

- All goods or services purchased will be subjected to South African National Parks Conditions of Contract;
- Penalty Clause (Servicing of diesel generators in KNP): The period of one week from the time of receiving a service request to arriving on site will be allowed of which any delays beyond that, penalties will apply.
- Penalty Clause (Breakdown emergency callouts): The period of 24 hours (one day) from the time of receiving an emergency callout to arriving on site will be allowed of which any delays beyond that, penalties will apply.
- All staff will be subject to integrity testing as and when required

SCOPE OF WORK

The contract is for servicing diesel generators and attend to emergency breakdown callouts **[as and when required]** for a period of five (05) years in the Kruger National Park.

RESPONSIBILITIES OF SANPARKS

- To provide the tendering company with information that will assist in submitting the tender.
- To give the tendering company access to the different facilities, should they require to do site inspection
- Monitor the performance of the supplier and propose mitigation plan
- Enter into a service level agreement with the bidder

- Return to the supplier any inferior goods within 30 days at the bidders cost
- Effecting payment within 30 days from date of receipt of original tax invoices.

RESPONSIBILITIES OF THE SERVICE PROVIDER

- The service provider shall act in good faith in conducting and providing services for the duration of the contract.
- The service provider shall adhere to the service level agreement
- The service provider shall refund SANParks a full amount or exchange for all inferior quality and damaged goods.
- A service provider shall respond within 24 hours of receiving a breakdown callout

PROJECT OR CONTRACT PERIOD (TIMEFRAMES)

The contract period will be for a period of Five (5) years. The contract for the supply of service in terms of this agreement shall come into being on the start date and shall continue in force for a period of five years until the end date.
