1.2. ALL BIDS MUST BE SUBMITTED ON THE OFFICIAL FORMS PROVIDED-(NOT TO BE RE-TYPED) OR IN THE MANNER PRESCRIBED IN THE BID DOCUMENT.

1. PURPOSE

The purpose of this exercise is to appoint a service provider who will provide SANParks with a venue and catering for the Fundraising Golf Day scheduled on the 21st June 2019.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

Specification

1. Description

Table Mountain National Park (TMNP) –is desirous of a service provider to sell green cards and activity permits on The Park's behalf for a period of 12 months

A green card is a clip entry card that allows the card holder x12 entries to Cape Point, Boulders, Silvermine and the TMNP picnic sites, valid for 365 days from date of purchase.

The applicant must produce x 2 ID photos of themselves, their ID and proof of residence not older than 3 months to purchase.

The Activity permit is a permit which allows the permit holder unlimited entry to TMNP to carry out their specified activity for the period of 365 days from date of purchase. The

applicant must produce ID or Passport and x 2 ID photos to purchase.

2. Scope of Work and Specification to be submitted with the quote

Scope

A supplier is required who can sell both activity permits and the green cards on behalf of Table Mountain National Park , a park within South African National Parks for a period of 12 months.

The sale of all activity permits and green cards will be based on the supplier receiving a percentage of the turnover of all sales.

Annual average sales figures are approximately R2.5 million (VAT inclusive) a year.

TMNP requires that cards and permits be made available for purchase from at least 5 different sites. These sites can be in a brick structure or kiosk

At least 3 of these outlets need to be operational on weekends which includes Saturdays and Sundays as well as public holidays.

These sites should be spread across the peninsula and located in diverse publically accessible locations across the municipality of Cape Town.

Spec to perform the work

Sales to be made as per manual to be supplied on award of bid.

The supplier will collect all revenue for the sale of such cards and permits and deposit into a dedicated bank account.

A monthly reconciliation of all sales needs to be supplied by the 7th of each month to SANParks for payment

TMNP will invoice the agreed revenue less commission by the 15th of each month.

The invoice amount to be paid into the SANParks bank account within 7 days of receipt of invoice.

Recon layout to be advised on award of bid.

Completed application forms from all sales sites to be delivered at month end to the Tokai sales office for capture onto the database.

The supplier will supply and or be responsible for:

The sales sites and cover all costs associated with the sites including but not limited to rental/ bond repayment, staffing, uniforms, stationary, electricity, water, rates and taxes, salaries etc.

Provision of Photocopier, paper and cartridges per site (inclusive of rental and maintenance of said equipment)

All bank charges incurred in collection of the funds and payment of said funds to SANParks for bidders account.

Hire and cost of all credit card machines for taking payments for all sales.

SANParks will supply

Cards and Permits, Application forms, Laminating pouches, Red Tape and Laminators for each site.

Training to be provided by provision of a manual and on-site at Tokai Office at commencement of contract and as new staff are engaged by service provider

All items to be collected and delivered to and from the Tokai Wild Card office in Tokai, Cape Town.

Range of permits and cards to be sold may vary over time depending on SANParks needs.

SLA to be signed on award to bidder.

- These sales are only estimated amounts. It is required that supplier quote accordingly on a percentage of revenue as a commission.

- SANParks will not allow price increase in percentage after Official Purchase Order has been issued.

4. TIMELINES

Upon appointment the recommended supplier is expected to confirm availability of their venue and catering as per the terms of reference on the RFQ, failure to deliver SANParks reserve the right to cancel the Purchase Order.

5. FINANCIAL PAYMENT

Payment will be made in accordance to the PFMA (within 30 days) after delivery of service rendered or goods delivered.

6.1. MINIMUM REQUIREMENTS COMPLIANCE RESPONSIVENESS CRITERIA (Compliance to legislative and treasury requirements)

In this phase all responses received will be verified for compliance and completeness of the submitted proposal per the below set of mandatory requirements.

8 EVALUATION CRITERIA AND WEIGHTING

The RFP stipulated that the responses to be evaluated using the 80/20 preference points system in accordance with the PPPFA guidelines. Based on this system the points will be allocated as follows:

9 EVALUATION FORMULA FOR PRICE

The following formula will be applied to calculate the scores:

Price Formula

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

10 FINAL AWARD

Bidder who complies with the specifications and scores highest total points on PRICE and B-BBEE claimed points shall be awarded the contract. SANParks reserves the right not to appoint.

10.1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) **“prices”** includes all applicable taxes less all unconditional discounts;
- (h) **“proof of B-BBEE status level of contributor”** means:
 - 1) certificate issued by an authorized body or person; B-BBEE Status level
 - 2) prescribed by the B-BBEE Codes of Good Practice; A sworn affidavit as

- (i) **“QSE”** means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (j) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

10.3 POINTS AWARDED FOR PRICE
