## 1. PURPOSE

To identify the correct supplier for the 29km fibre optic cable removal within the appropriate allowances of fibre optic and correct operation to prevent damage to the fibre optic cable..

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## SCOPE OF WORK

### BACKGROUND

The Eastern Perimeter Detection System (EPDS) was installed in 2016, to serve as a detection system for illegal poachers crossing the boundary into the KNP. Once installation was completed, the system was maintained for a period of 3 years.

The system includes the following main components:

- 29km FOC seismic cable install +/- 500cm (0.5m) on the main eastern boundary fence.
- Godleni picket upgrade and power management system installed.
- Local controller installed.
- Lead-in cable installed.

The removal of the FOC cable and safe storage thereof has been approved. SANParks, KNP thus requires the correct supplier, with appropriate experience in dealing with fibre optic cable, to remove the FOC safely without damage, as this system will be re-deployed in KNP.

### FIBRE OPTIC CABLE (FOC)

The FOC is a specialised fibre optic cable that requires specific understanding and knowledge of handling in order to prevent FOC damage and safely recoil the existing FOC onto 4 km cable drum. This requires a specialist service provider with an existing track record in operating and working with FOC cable.

The following provides a guiding to the requirements for FOC removal:

1. Truck and crane for lifting and transporting 4km cable drums. Confirmation of ownership of all equipment is required
2. Removal of the FOC cable from the fence.
3. Cable re-drumming equipment. Re-coiling of 4km FOC cable onto new cable drums. Equipment to include the following:
  - a. Re-spooler
  - b. Reel handling equipment (forklift or hand truck)
  - c. Counter
  - d. Staples, hammer, cable ties (depending on reels)
  - e. Cable cutter
  - f. Hand micrometer or dial calipers
  - g. Reel
  - h. Vinyl tape (depending on cable)
4. The required knowledge and experience in working with Fibre Optic Cable.
5. Removal of dome joints to sector 29km of FOC into 4 km sections.
  - a. Appropriate splicing/cutting of the cable.
  - b. Dome joint removal.
6. The required understanding of fibre optic cable limits for the safe removal thereof.
7. Supplier to provide evidence of understanding, knowledge and experience in working with Fibre Optic Cable.
8. Previously working and dealing with a system of an asset value R 20 000 000, and a project value of R300 000, relating to fibre optic cable.
9. Provide the proof of required SAQA accredited certificate in dealing with Fibre optic cable.

## **SUBMISSION OF BIDS**

Bidders should ensure that bids are delivered timeously to the correct address. If the bid is late, it will not be accepted for consideration.

Bidders shall submit proposal responses in accordance with the prescribed manner of submissions as specified above. Bids received after the time stipulated shall not be considered.

SANParks may request clarification or further information regarding any aspect of the bid. The bidder must supply the requested information within 48 hours or unless otherwise indicated after the request has been made; otherwise the bidder may be disqualified.

## **EVALUATION PHASES**

The received bid proposals will be evaluated in different phases in order to arrive to the final phase of bid award, and the phases will be as follows:

**STAGE ONE (01):** Minimum Requirements Compliance Screening (**as prescribed in 6.1 below**)

### **STAGE TWO: PRE-QUALIFICATION REQUIREMENTS**

- Minimum B-BBEE **level 3** (no service provide that are level 4-8 will be considered for this RFQ)

- Provide the proof of required SAQA accredited certificate in dealing with Fibre optic cable
