1. PURPOSE

The purpose of this exercise is to appoint a service provider to provide alarm monitoring and armed response for the Tokai wild card office in Table Mountain National Park for a period of 24 months effective 1 February 2021.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*.

SANParks' operations are guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly

3. SCOPE OF WORK

To provide alarm and armed response services to the Tokai wild card office in Tokai

1. Background

To provide alarm and armed response services to the Tokai wild card office in Tokai. Single free standing building with electricity

2. Description of Required Services

The required services include:

Provision of an alarm system for the office

Provision of armed response for the office at the address: Top end Tokai Road Tokai (no street number as we fall outside city boundary)

3. RFQ Costing Schedule

- b) Provision of armed response service to the office
- c) Annual radio fee
- d) Alarm panel if current panel cannot be utilized
- e) Panic button if current buttons cannot be used

8 EVALUATION CRITERIA AND WEIGHTING

The three main elements of the bid

Bids will be evaluated on three main elements: functionality, BEE and the cost.
Bidders must score at least 80% for functionality to qualify for the next phase.

The weighting of the elements

Functionality will be weighted at 80 % of the overall bid score,

BEE scored out of 20 points,

Price will be scored out of 80 points.

The provisions of the Preferential Procurement Policy Framework Act, 2000 (PPPFA) apply.

10 FINAL AWARD

The bidder that receives the highest overall score will be appointed the preferred bidder.

10.1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by

the purchaser.

- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
