A **digital version on USB/Memory stick** containing the bid document and all other supporting documents (fully submitted bid proposal with its attachments) must be provided of all tender documentation within the bid envelope.

These serve as the original sets of bid documents and form part of the contract. SANParks with the awarded bidder sign these original contracts in black ink. The signed legal contract constitutes the closure of the competitive bid/tender/request for quotation process and sets out each party's obligations for executing the contract. These original document sets serve as the legal bid document and the contract document between the bidder and SANParks. The bidders attach the originals or certified copies of any certificates stipulated in this document to these original sets of bid documents.

Bids must be hand delivered or (if couriered) reach SANParks by no later than the specified closing date and time. Tenderers should ensure that tenders are delivered before the closing date and time to the correct address. If the tender is late, it will not be accepted for consideration.

RETURNABLE DOCUMENTS

COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS

(Standard Bidding Documents)

The verification during this stage is to review bid responses for purposes of assessing compliance with RFB requirements, whereby a bidder may be disqualified if they do not fully comply, which requirements include the following:

MANDATORY EVALUATION CRITERIA (mandatory returnable documents)

Failure to comply with Mandatory Requirements may lead to the bidder being disqualified, and not considered for further evaluation on the Technical and Price and Preference requirements.

1. Proof of valid registration with PSIRA.
2. Valid PSIRA (Private Security Industry Regulatory Authority) Letter of Good Standing.
3. Valid Company Director PSIRA (Private Security Industry Regulatory Authority) Registration.
4. Valid registration or licenses with ICASA for radio Frequency and in case the bidder is not the holder of the licence he / she should provide the third party registration certificate where they are hiring the radios.
5. Company must also attach a list of permanent registered guards.
6. Occupational Health and Safety Policy / Plan of the company.
7. Contingency Strategy – Indicate a contingency strategy going to be applied in case of Urgent delivery / Public Strike / Own Strike / Vehicle Breakdown / Festive Season / Covid-19.
8. Letter of Good Standing on Compensation for Occupational Injuries & Diseases Act (COID) for Security Services or an Accredited Institution.
9. The bidder must provide a letter of undertaking that they will obtain Public Liability Insurance for a minimum of R10 million upon award of this tender.
10. Audited Financial Statement for 2020/2021.

CENTRAL SUPPLIER DATABASE INFORMATION

THE BIDDING SELECTION PROCESS

EVALUATION PHASES

Phase 1 – Compliance and Governance verification:

The verification during this stage is to review bid responses for purposes of assessing compliance with RFB requirements, whereby a bidder may be disqualified if they do not fully comply.

Phase 2- Mandatory evaluation criteria

The bidder must indicate its compliance / non-compliance to the requirements and should substantiate its response with supporting evidence. If more space is required to justify compliance, please ensure that the substantiation is clearly cross-referenced to the relevant requirement.

Failure to comply with Mandatory Requirements may lead to the bidder being disqualified, and not considered for further evaluation on the Price and Preference requirements.

Phase 3 – Functionality Evaluation

In this phase All bids that met all the requirements in terms of compliance and completeness of the submitted proposal per the above set of mandatory requirements will be evaluated as follows:

Qualification Threshold – Bidders must achieve minimum 70% as per the criteria for consideration to the next phase of evaluation. Bidders who fail to comply with the set minimum threshold of 70% as per the technical requirements will be eliminated and bidders who comply with the technical requirements will progress to phase (04) of the evaluation.

Phase 4 – Price/Preference Evaluation

Basis of competition and due diligence tests for reasonableness of price:

SANParks compares each bidder's pricing proposal on an equal and fair comparison basis that is equitable to all bidders taking into account all aspects of the bids pricing requirements.

SANParks conducts fair market-related pricing tests to arrive at an opinion of reasonableness of the bid price offered.

Where these due diligence tests reflect defective pricing or pricing outside of the fair market-related price range, the evaluators will recommend price negotiation with the winning bidder to bring the price within the fair market-related price range as tested.

Where the winning bidder does not want to participate in the price negotiation or provide a fair market-related price, SANParks cancels the award and commences price negotiations with the second bidder in the price/preference ranking.

Ranking of the bidders pricing:

SANParks ranks the qualifying bids on price and preference points claimed in the following manner:

Price – for bids qualifying for this stage, the lowest priced Bid receives the highest price score as set out in the Preferential Procurement Regulations of 2017;

Preference - for bids qualifying for this stage, addition of the claimed preference points in the preference claim form (SBD6.1) where supported by a valid BBBEE certification to the price ranking scores.

Award recommendation:

SANParks nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

SANParks reserves the right not to award to the highest points scorer in accordance with S 2(1) (f) of the Act (PPPFA).

Due Diligence Phase

Where circumstances justifies it, SANParks reserves the right to conduct due diligence (interviews, presentations, site visits) with shortlisted bidders who meet the mandatory evaluation criteria, whereby bidders will present further information or provide further proof to the evaluation committee. In these cases, SANParks may provide the areas of concern to the short listed bidders to address in their presentations. Bidders will be evaluated on the below criteria and bidders who meet the below requirements will progress to the next phase of evaluation of price and preference.

BID PROCEDURE CONDITIONS:

Counter Conditions

SANParks draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

Response Preparation Costs

SANParks is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

Cancellation Prior To Awarding

SANParks reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range (in terms of the Preferential Procurement Regulations of 2017), or any process impropriety.

Collusion, Fraud And Corruption

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

Fronting

SANParks, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should SANParks establish any of the fronting indicators as contained in the Department of Trade and Industry’s “Guidelines on Complex Structures and Transactions and Fronting” during such inquiry/investigation, the onus is on the bidder to prove that fronting does not exist? The purpose of this bid is to invite prospective bidders to submit a bid for the provision of security guard services at the Tsitsikamma section of the Garden Route National Park.

CONTRACT PERIOD

The contract will be for a period of three (3) years.

SPECIFICATIONS

- . The security services shall protect SANParks employees, Accommodation facilities, information and assets against any damages, injuries, vandalism, theft, sabotage, death and any other security risk or threat.
- Daily execution of access and exit control at the specified areas
- **Patrol and safeguard buildings and areas as indicated below, seven days a week from 18h00 to 07h00 at Stormsriver mouth:**
Main entrance gate
Reception, Administration offices, Technical stores, Paul Sauer-Hoek
Otter Camp
Dolphin Camp
Restaurant Camp, Guest houses and Petrusville.
- **Patrol and safeguard buildings at Tsitsikamma Big Tree and Stormsriver Village offices and stores complex, seven days a week from 17h00 to 07h00.**
- **Patrol and safeguard buildings at Nature's Valley Rest camp, Bloukrans complex, tower houses, seven days a week from 17h00 to 07h00.**
- Gate control at the main entrance gates, record all visitors and vehicles entering and leaving the Park.
- Conduct random searches on all vehicles entering and leaving the Park.
- Compile reports of incidents of security breaches taking place during shift operations.
- Carry out lawful security instructions/orders issued by identified SANParks representatives from time to time.
- React and report any emergency situations to the relevant emergency services, e.g. ambulance services, fire department, police station, Senior Section Ranger, Hospitality Services manager immediately when the emergency occurs.
- Ensure that the security registers are neat and up to date at all times.
- Comply with the Occupational Health and Safety Act and regulations
- Ensure compliance with all relevant legislation pertaining to a National Park.
- The Company must ensure quality service by adhering to SANParks operational plan / instructions. Operational plan and specific needs/duties/instructions will only be discussed with the successful bidder.
- Guards must be well trained in security services and must have traceable references
- Guards must not have any criminal records (SANParks may request proof of Police Clearance Certificate)
- Guards must be able to communicate in English and at least one other South African official language
- Guard quantity and grade:
 - Storms River Mouth Main gate: 2 x grade C guards.**
 - Natures Valley Rest Camp: 2 x grade C guards.**
 - Big Tree: 2 x grade C guards**
 - Site or Shift Supervisor**
 - Patrolling vehicle**
- Provision of Extra Guards to patrol the above mentioned areas where the permanent guards will not be based, during the Peak Period or as the need arise at the Storms river rest camp, Dolphin camp, Otter camp, Nature's Valley, Big Tree, Restaurant area & Guest houses at Petrusville: Grade C Guards (preferred on vehicle patrol) for quick response.
- Own vehicle to transport guards.
- Guards must wear the Security company uniform and be presentable at all times.
- The Security Company is responsible for transportation of the guards.
- Security Company to abide by Basic Conditions of Employment Act and all applicable legislation.
- Guards will be expected to perform certain admin duties in terms of access control and assistance with after hour visitors.
- Training on SANParks standard operating procedures in terms of specific duties and responsibilities will be conducted 3 days prior to the commencement date of the contract. The process will be managed by SANParks delegated officials.
- Identify suspicious movement in and around the identified areas and inform management accordingly.
- Respond to all security related incidents and duties as stipulated in SANParks SOP.
- Perform all duties with diligence and professionalism at all times.
- Guards must report for duty 15 minutes before starting of the shift at each site.
- All incidents observed must be recorded in the OB book and copies thereof provided daily to the delegated SANParks official.
- Ensure that only authorized people, visitors, contractors, service providers enter the premises.
- Security guards must be armed with pepper spray and a baton.

- Security Company must provide clock panels on strategic places per site where roaming guard/s must clock in every hour.
- Roaming hours will be specified by SANParks and communicated to the successful bidder. Quotation for the clock panel system must be indicated separately on bid quotation forms. The clock panel system will remain the property of the Service Provider. The amount of clock panels per site will be with the successful bidder.
- Spot checks not less than once a week must be conducted by security company supervisors / operational managers and proof thereof provided in monthly reports.

RESPONSIBILITIES OF THE SERVICE PROVIDER

- Ensure that security guards/personnel is starting and ending the work shifts as specified above.
- Ensure that off-sick personnel are replaced without interruption of the services.
- Keeps a record of daily occurrences as well as the attendance register of the personnel on duty. Attendance Register to be signed by the guards when reporting for duty and when works shift ends. Attendance Register to be signed by the supervisor for monitoring.
- Ensure that personnel is always dressed in full uniform.
- Ensure that personnel are well mannered and respectable at all times when on duty.
- Ensure that personnel do not sleep whilst on duty.
- Ensure that personnel does have all the necessary equipment to perform their duties.
- Ensure that guards arrive on site by at least 16h45 for handover purposes and to be at their work stations at 17h00 for night shift.

SPECIAL CONDITIONS OF CONTRACT

- Bidders are required to provide their own accommodation for guards
- Times may change as per SANParks' need and will be agreed with the service provider to require ad hoc guard/s as need arise in high guest volumes.
