1. PURPOSE

The purpose of this exercise is to appoint a supplier for supply and delivery of 8 mobile laboratories.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

The scope of work for the mobile laboratories are as follows,

8 Mobile Laboratories – MAK Series 1200 Description or Equivalent

The mobile science laboratory unit is manufactured from composite materials. The unit is initially aimed for use in the educational sector for the demonstration of science laboratory experiments.

The unit comprises of an exterior composite panel. In the case of the laboratory use, the interior of the unit holds purpose-made shelves intended to hold the experiment apparatus as required by the experiment. It is therefore designed to handle multi subject experiments.

The entire assembly is mounted on lockable wheels to enable mobility.

Overall dimensions of the Mobile Lab are as follows:

- Length: 1.2m
- Width: 0.75m
- Height: 1.1m
- Weight: ± 40kg

Product Features

- The unit replaces the conventional four-walled science laboratory and can be moved from class to class and can be easily pushed by one person.
- It ensures safety of the glassware as these are mounted on specially designed shelves that prevent breakages as the unit is being moved from class to class
- The unit is a space saver and is cost effective.
- It allows for the conducting of experiments at a closer look and also observation
- Its two side flaps allow for a working area that is scratch resistant and easily cleanable
- One top flap is a sink to dispose of liquids after use
- The other top flap is a writing board
- It is lockable for the safety and security of the fitted equipment

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

SANParks reserves the right not to award to the highest points scorer in accordance with S 2(1) (f) of the Act (PPPFA).
