## THE BIDDING SELECTION PROCESS

### Phase 1 – Compliance to minimum administrative documents

Bidders warrant that their proposal document has, as a minimum, the specified documents required for evaluating their proposals as set out in the Returnable Document List.

### Phase 2 – Compliance with mandatory requirements

In this phase bid responses are verified against the set of mandatory requirements. Bidders who fail to comply with the requirements may not proceed to the next phase of evaluation.

### Phase 3 – Price/Preference Evaluation

Basis of competition and due diligence tests for reasonableness of price:

SANParks compares each bidder's pricing proposal on an equal and fair comparison basis that is equitable to all bidders taking into account all aspects of the bids pricing requirements.

SANParks conducts fair market-related pricing tests to arrive at an opinion of reasonableness of the bid price offered.

Where these due diligence tests reflect defective pricing or pricing outside of the fair market-related price range, the evaluators will recommend price negotiation with the winning bidder to bring the

price within the fair market-related price range as tested.

Where the winning bidder does not want to participate in the price negotiation or provide a fair market-related price, SANParks cancels the award and commences price negotiations with the second bidder in the price/preference ranking.

Ranking of the bidders pricing:

SANParks ranks the qualifying bids on price and preference points claimed in the following manner:

**Price** – for bids qualifying for this stage, the lowest priced Bid receives the highest price score as set out in the Preferential Procurement Policy Framework Act;

**Preference** - for bids qualifying for this stage, addition of the claimed preference points in the preference claim form (SBD6.1) where supported by a valid BBBEE certification to the price ranking scores.

**Award recommendation:**

In the case of this bid, SANParks will appoint the top three (3) bidders with the highest combined score to the panel, subject to the bidder having supplied the relevant administrative documentation.

**BID PROCEDURE CONDITIONS:**

**Counter Conditions**

SANParks draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

**Two Envelope System Required for Technical and Pricing**

The objective is to evaluate the Proposals Section without reference to the Price Section ensuring both sections are evaluated fairly and unbiased.

The first envelope (first secured PDF) holds all documents excluding the SBD 3 (price summary schedule) and detailed supporting pricing documentation. The second envelope (second secured PDF) holds the SBD 3 and the detailed supporting pricing documentation. An outer envelope encloses both envelopes.

SANParks only opens the technical proposal at the evaluation stage and only opens the pricing proposal for those bidders who meet the predefined threshold at the proposal evaluation.

**Response Preparation Costs**

SANParks is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

**Cancellation Prior To Awarding**

SANParks reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range (in terms of the Preferential Procurement Policy Framework Act), or any process impropriety.

**Collusion, Fraud And Corruption**

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

**Fronting**

SANParks, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Should SANParks establish any of the fronting indicators as contained in the Department of Trade and Industry’s “Guidelines on Complex Structures and Transactions and Fronting” during such inquiry/investigation, the onus is on the bidder to prove that fronting does not exist? Failure to do so within a period of 7 days from date of notification will invalidate the bid/contract and may also result in the restriction of the bidder to conduct business with the public sector for a period not exceeding 10 years, in addition to any other remedies SANParks may have against the bidder concerned.

## INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a sustainable National Park System connecting society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System.

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

## INTRODUCTION TO SANPARKS BUSINESS UNIT RESPONSIBLE FOR THIS BID

- Veterinary Wildlife Services (VWS) will be able to achieve this by developing and managing a system that represents the biodiversity, landscapes, and associated heritage assets of SANParks for the sustainable use and benefit of all.
- Lucerne is the foundation of the nutrition for wildlife kept in SANParks holding facilities during pre-sale periods and research trials. SANParks image is closely associated with the ethical and responsible management of its wildlife and keeping wildlife in captive conditions under its care must be done professionally and ethically.
- SANParks therefore cannot compromise with the quality of food the organisation provides to wildlife that is kept in its holding facilities. With the decision by EXCO in support of additional wildlife sales to generate income towards the Park Development Fund for managing the national park system as well as the ever-changing weather conditions, there has been a requirement for sourcing first-grade Lucerne, since it provides the best quality product, to feed animals on sale and for research purposes kept in SANParks holding facilities.

## CONTEXT OF THIS PROCUREMENT

The appointment of a panel of suitable service providers for the supply and delivery of first grade Lucerne and Eragrostis Grass to South African National Parks.

## CONTRACT PERIOD

The duration of this contract will be for a period of three (03) years.

## SPECIFICATIONS

### SCOPE OF WORK

- SANParks aims to appoint a panel of suitable service providers that have the capability and understanding to provide fodder to SANParks. Bids are sought from reputable reliable suppliers that have experience and capability in the supply and delivering of first grade Lucerne and Eragrostis grass.

### DELIVERABLES

- All Lucerne and Eragrostis grass must be of first grade quality, from current year.
- Each load of Lucerne must be accompanied with a Lucerne Quality Index (LQI) issued by a Member of the National Lucerne Trust (NLT) which must confirm the loaded parameters and LQI ranging between 97 – 103. Index.
- All Lucerne and Eragrostis grass rectangular bales must be from the current season.
- All Lucerne and Eragrostis grass must be delivered in square / rectangular form.
- All Lucerne and Eragrostis grass must not be contaminated with weeds or toxic plants or any other species of plants / grasses not ordered.
