1. PURPOSE

The purpose of this submission is to obtain approval for the Request for Quotation (RFQ) for the appointment of a consultant to analyse, diagnose and develop an improvement plan for SANParks' management of its B-BBEE component.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

The Broad-Based Black Economic Empowerment Act 53 of 2003 ("**BBBEE Act**") provides the legislative framework for Broad-Based Black Economic Empowerment ("**BBBEE**") in South Africa. Codes of Good Practice may be issued by the Minister of Trade and Industry under the BBBEE Act, and such Codes may be "generic" (i.e., of general application) or apply to a specific sector of the economy (so called sector codes that are developed by stakeholders in the relevant sector). The current "generic" Codes of Good Practice ("**Codes**") were published on 11 October 2013 and came into effect on 1 May 2015.

The primary purpose of the BBBEE Act and the Codes is to address the legacy of apartheid and promote the economic participation of Black People in the South African economy. Apart from the overall aim of a B-BBEE verification (i.e., to promote greater black economic participation, thereby empowering those who were disadvantaged and redressing some of the ills of the past), it is a requirement from the B-BBEE commission that a sphere of government, public entity or an organ of state to report annually to the B-BBEE Commission, within (thirty) 30 days of the approval of such audited financial statements and annual report.

SANParks as a responsible public good organisation strives to abide by B-BBEE compliance legislation by having its B-BBEE scorecard verified on an annual basis by a registered and credible verification agency. In so doing SANParks aim to lead by example by continuously improving in our B-BBEE performance as an organization.

At present, SANParks holds a B-BBEE rating of Level 8. A rating this low gives the appearance of a non-transformed organisation, which SANParks categorically is not. In terms of the organisation's Integrated Transformation Strategy, it is important to look at the B-BBEE Scorecard and to identify (1) the key areas that are driving this low score and (2) ways in which the score could be improved.

3. SCOPE OF WORK

SANParks seeks to contract a Service Provider/ Consultant, to assist SANParks in improving its overall B-BBEE management and compliance levels for six months

The services provider will be required to do the following:

- (1) A desktop analysis of SANParks' last three years' B-BBEE level of compliance reached
- (2) Do a detailed verification of required vs. submitted documentation in consultation with the divisional staff responsible for record keeping and reporting;
- (3) Diagnose the areas for improvement with the Transformation Team and;

(4) Develop a B-BBEE improvement plan for SANParks.

The improvement plan should address all areas of non-conformance. Once analysed, the service provider will be expected to provide an improvement plan to address non-conformance within the following areas:

- Management Control
- Skills Development
- Enterprise and Supplier Development and
- Socio Economic Development

4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply which requirements as stipulated below:

- Submission of fully completed SBD1 (Invitation to Bid),
- Submission of a quotation on the company letterhead,
- Submission of fully completed SBD 4 (Bidder's disclosure),
- Submission of fully completed SBD 6.1 (Preference Claim Certificate), accompanied by the relevant documentation to proof the specific goals claimed
- Submission of fully completed SBD7.2 (Contract Form),
- General Conditions of a Contract

5. CENTRAL SUPPLIER DATABASE INFORMATION

Bidders are required to be registered on the Central Supplier Database (CSD) of National Treasury. Failure to submit the requested information may lead to disqualification. (Please provide proof of registration on the Central Supplier Database).

6. EVALUATION PHASE: MANDATORY REQUIREMENTS

The service provider will be disqualified if they do not fully comply with all mandatory requirements. No “unanswered” questions will be allowed. The proposal must include:

- Details of the service provider, including relevant skills, experience and track record.
- A brief description of the approach and deliverables.
- At least one example of recent work within the B-BBEE field the service provider was personally responsible for in order to demonstrate skills and experience.

- A work plan, including proposed start and completion date and timeframes for activities and deliverables against which payments will be made.
- A detailed and complete budget for the proposed work, including fees (number of days and rate per day), disbursements and VAT. Each of these should be provided separately.
- Travel and accommodation should be included in the budget. Travel requirements will be discussed at the inception meeting.
- Details of any contribution to empowerment of historically disadvantaged individuals (HDI) and/or transformation of the sector.
- Equity status of service provider (BBBEE scorecard of good practice) according to the attached form (SBD 6.1).
- Contact details of at least three current or recent clients.

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

The contracted party shall procure where necessary the signatures of its personnel for the assignment of the contract intellectual property to SANParks, or as SANParks may direct, and to support SANParks, or its nominee, in the prosecution and enforcement thereof in any country in the world.

The contracted supplier hereby irrevocably appoints SANParks to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that SANParks, in its absolute discretion, requires in order to give effect to the terms of this clause.

The rights and obligations set out in this clause shall service termination of this contract indefinitely.

Confidentiality

The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with SANParks and after termination of its involvement with SANParks, the recipient shall not:

- (a) Disclose the confidential information, directly or indirectly, to any person or entity, without SANParks' prior written consent.
- (b) Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or
- (c) Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract.

The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to

- (a) Disclose the confidential information to any third party, or
- (b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,

The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

- (a) Was independently developed by the recipient prior to its involvement with SANParks or in the possession of the recipient prior to its involvement with SANParks;
- (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;
- (c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from SANParks, or
- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
