## 1. PURPOSE

The purpose of this RFQ is to invite a supplier for photography in Table Mountain National Park-Lion's Head area.

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## 3. SCOPE OF WORK

### 1. Service description and scope of work

The Table Mountain National Park (TMNP) is one of 22 National Parks managed by South African National Parks (SANParks). The protected area consists of several iconic tourist destinations, including Table Mountain, Lions Head, Signal Hill and Cape Point and receives over 4.5 million visits per annum across the Park. These visitor numbers create a platform for business opportunities in the Cape Town area.

SANParks, as a parastatal organ of state, wishes to promote entrepreneurship and support of SMMEs as a driver of the local economy. To this end, TMNP wishes to invite prospective commercial operators and traders to quote for photograph in the Table Mountain National Park – Lions Head.

The location is Lion's Head area and it is confined to the TMNP Northern Section of the Park. In terms of the Park Management Plan, TMNP makes provision for a Tourism Product Development Framework. This details a guideline to inform the development potential of the Park. Identified opportunities remain subject to comprehensive feasibility studies and applicable permitting requirements prior to implementation. Therefore, listing an activity does not automatically result in development or implementation.

The opportunities identified for the site(s) include:

- Use of Camera (note: photographed people must consent)
- Photo printer
- Medium tripod
- Activities to take place on designated paths

SANParks will only consider applications that fall within the listed activities. Operating must take place within the defined footprint of the trading space.

The trading site has a pre-determined location and footprint (extent) from which the trader may not deviate.

The trader must include in their submission:

- Full description of the proposed business operation;
- Price quoted for the site being tendered on;
- All SBD documentation included in this bid;
- Valid Tax Clearance documentation;
- Valid CSD Compliance Report

Information provided by the Service Provider in the Quotation shall constitute a binding offer to the TMNP that shall form part of any subsequent contract between the parties.
