



**NOTICE OF A BASIC IMPACT ASSESSMENT
PUBLIC PARTICIPATION MEETING NOTIFICATION
PROPOSED CONSTRUCTION OF THE PHALABORWA WILDLIFE ACTIVITY HUB, KRUGER NATIONAL PARK,
LIMPOPO PROVINCE**

Proposal: The proposed project is one of three SANParks enhancing projects earmarked by the Department of Tourism for the 2016/2017 financial year to ensure tourism attraction and provide job creation for Local Communities. The specific site was chosen due to its close proximity to Phalaborwa, thus eliminating the need for additional guest and staff housing.

Various animal sanctuaries will help educate the public and will be aimed at public awareness (Rhino Poaching). Nine different hubs (discussed below) will be looked at with interlinking shuttle system connecting the various activity hubs with a hop-on hop-off experience. Thus public parking will be catered for and no private vehicles will be given access to the development.

The proposed project entails the development of the following infrastructure:

- Activity Hub;
- Backpacker Facilities;
- Two Bird Viewing Areas;
- Two Cool Down Areas;
- Rhino Orphanage;
- Entrance Gates;
- Tent Camps;
- Specific Activities Areas;
- Public Areas (Braai Areas, Picnic Sites & Ablution Facilities)

This development requires Environmental Authorisation and is therefore subjected to a Basic Assessment Report in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA).
