**INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

### **BUSINESS UNIT RESPONSIBLE FOR THE BID**

The Conservation Services Unit within the Karoo National Park falls under Parks Division (SANParks) with its mandate of conserving, protecting, controlling and managing the protected areas and biodiversity.

### **CONTEXT OF THIS PROCUREMENT**

The purpose of this bid is to invite prospective bidders to submit a proposal for the provision of gate access control in Karoo National Park (Beaufort west) for a period of five (5) years.

### **CONTRACT PERIOD**

The contract will be for a period of Five (05) years

### **SPECIFICATIONS/SCOPE OF WORK**

SANParks seeks to appoint a reputable and professional security services company for provision of access control at the main entrance gate of Karoo National Park, in Beaufort West.

Although Karoo National Park has its own gate guard on duty during office hours at the main gate, additional security guards are required to man the gate after office hours and during weekends and public holidays. The services would be for access control only, therefore the security guard grading on grade C would be sufficient. Only one security guard per shift would be required to work at the main gate except in cases where training needs to be given to additional security guards when more than one security guard may be present at the main gate.

## **1. SPECIFICATIONS**

**SERVICES REQUIRED:** A service will be required 365 days of the year and would include the following;

- Night shift duties on Mondays to Sundays from 16:00 till 7:00 (next morning).
- Day shift duties on Saturdays, Sundays and Public Holidays from 7:00 till 16:00.

- A 30 day period when the permanent gate guard is on leave.
- The work will entail access control according to the Standard Operating Procedures (SOP) – Access Control for Karoo NP, this document will be made available to the successful service provider.
- Completion of gate registrations and indemnity docket for all guests.
- Declaring, sealing and registering of fire arms of visitors.
- Radio duties as required by SANParks.
- Completion of official registers.
- Provide keys to late arrivals (guests).

- The site to be serviced is Karoo National Park.
- Security services company must be registered with the Private Security Industry Regulatory Authority (PSIRA)
- Guards must also be registered with PSIRA
- Security Company must also attach a list of permanent Registered guards
- Company must ensure quality service
- Guards must be well trained in security services and must have traceable references
- Guards must not have any criminal records. The successful service provider shall provide police clearance of the guards on commencement of contract
- Guards must be able to communicate in English and Afrikaans
- Guards must be punctual
- Guards must wear Security Companies uniform at all times and be neat and presentable

**2.1 Training**

Staff should have relevant training and registration with PSIRA. Staff should at least be able to communicate in English as well as in Afrikaans and be able to read and write both languages. All staff working at Karoo NP's main gate should undergo induction training by SANParks that would include Code of Conduct SANParks, Rules and Regulations, SOP – Access Control, Legislation applicable to Protected Areas. This training would be provided by SANParks and it is expected from the service provider to avail all staff and relief staff to attend this training.

**2.2 Uniform**

It is expected from the service provider to provide uniform to the security guards that will be in line with the image and profile of SANParks and as prescribed by the Security

Industry Regulation Authority. It will be expected from all security guards to report to work in full uniform. Their uniform should make provision for colder weather as well, especially during the winter period. Jackets and/or rain coats should be provided.

### **2.3 Transport**

The service provider is responsible for the transport of its own staff to and from the work place. An overnight facility will be made available to the security guards during night shifts. This facility is situated at the main entrance gate.

### **2.4 Performance Management**

The service provider should have a performance measurement system in place to evaluate and manage performance of its employees.

It is also advised that the service provider shall have a duty sheet to ensure all staff on duty are familiar with the duties as required in the contract. The service provider shall thus have a comprehensive duty sheet prominently displayed at each point where security service is provided

### **2.5 Operational Equipment**

The following equipment would be expected to be supplied by the service provider to the security guards and must be in a working condition;

- Black pens
- Flash light with extra batteries
- A two-way portable radio with communication with the control room of the service provider.
- Incident report book
- Security equipment – discretion of the service provider but at least one can of pepper spray per security guard.

### **2.6 Discipline and Code of Conduct**

The Contractor will immediately remove a security guard from its duties within the Park should SANParks provide evidence of –

- Bribery, theft, on duty while under the influence of alcohol or drugs, sleeping on duty, Contravention of uniform rules, not being polite and presentable, eating and drinking while working with the public, chewing gum while working with the public, littering and not preventing littering, negligence in

recording people and vehicles entering the Park, incorrect recording of detail in the official registers, deviation from search instructions.

- The above mentioned action should provide grounds for removal of a security guard from its duties within the Park.
- The Contractor undertakes to investigate and take disciplinary action against a security guard against whom SANParks has a complaint if deemed necessary.
- Security guards with a negative criminal record.

## 2.8 Duties of the guards

- Guards are responsible for the security of SANParks visitor facilities; buildings, vehicles, all equipment and assets, managing access control sheet, checking of guest permits, searching of vehicles at the main gate.
- Duties will include patrolling, locking of gates; regular (hourly) patrols of the grounds, check for open doors and windows etc. and managing reporting of illegal access after-hours in line with park entry times, completion of gate registrations and indemnity dockets for all guests.
- Duties will be monitored via daily reports submitted to SANParks designated managers for scrutiny.
- Declaring, sealing and registering of fire arms of visitors.
- Perform radio duties as required by SANParks.
- Completion of official registers. Provide keys to late arrivals (guests).

## **RESPONSIBILITIES OF SANPARKS**

### **SANParks shall:**

- Monitor the professional security services that SANParks receives from the Service Provider.
- Give indication of unsatisfactory performance to the attention of the company's management for improvement and expect feedback on how such unsatisfactory performance or bad behaviour will be prevented for future occurrences.
- Review the received monthly report and provide feedback.

- Effect payment within 30 days from the date of receipt of original tax invoices for services rendered.
- Tax invoices submitted by the service provider will not be processed with respect to any non-compliance until credit notes are received.

- Operate 365 days per annum and 366 days in leap years without interruption.
- Adhere to health and safety regulations as well as labour related laws at all times.
- The Service Provider will provide within 7 working days of commencement of the contract the personal details of the security staff for the site as well as certificates showing theory grading as registered with PSIRA and police

clearance certificates including specialised certified training with respect to the guards.

- Ensure that its security personnel are always at the post at the required time per the service level agreement.
- Ensure that off-sick security personnel are replaced without interruption of the services;
- Keeps the record of daily occurrences as well as the attendance register of the security personnel on duty. Attendance Register to be signed when reporting in for duty and when leaving for the day. Register to be signed and maintained by the supervisor for monitoring;
- Issue room keys to guests on late arrivals
- Log in complaints/ incidents in the OB book
- Accepting courier parcels at main gate
- Ensures that the occurrence book on each site is provided, maintained and accurately filled in during the shift and scrutinized and signed off by a designated security services supervisor weekly.
- Ensure that supervisors conduct regular site inspections to ensure staff site compliance, maintain standards and check on the operation of equipment.
- Ensure that security personnel are always in full uniform and tidy;
- Ensure that staff are conversant in English given the high number of international tourists visiting the parks facilities.
- Ensure that security personnel are well mannered and respectful at all times when on duty;
- Ensure that security personnel do not report on duty drunk or under the influence of intoxicating substances, nor drink intoxicating substances when on duty.
- Ensure that security personnel do not sleep on duty.
- Ensure that security personnel keep all relevant records (entry record, movable property record and exit record register);
- Ensure that security personnel are always available to assist in any form of emergency at the main gate;

- Ensure that management is always available to respond to any complaints from either visitors or SANParks related to security services;
- Ensure that all complaints are addressed and a formal report afforded to SANParks on how the complaint was resolved and how such will be prevented in future within 7 working days from the day of occurrence;
- Maintenance of security services standards that SANParks receives from the Service Provider; and
- Submit invoice together with the attendance register on every last day of the month to SANParks as well as credit notes for late coming and patrolling as recorded by the security monitoring system.
- Effect payment within 30 days from date of receipt of original SANParks tax invoice for non-compliance e.g. late coming and non-compliance.
- Sign off SANParks Standard Operating Procedure within 30 days after submission by SANParks
- Service provider will be required to transport guards to all sites to ensure punctual commencement of shifts

## **COMPETENCIES OF THE SERVICE PROVIDER**

- The service provider shall act in good faith in fulfilling its obligations in terms of these operational requirements.
- Karoo National Park (SANParks) shall be entitled to use the findings of customer satisfaction surveys, spot-checks and audit reports or complaints to determine the level of compliance by the service provider with regard to the service standards and responsibilities stipulated in this document.
- Should Karoo National Park (SANParks) at any time believe that any member of the service provider's personnel is failing to comply with their operational requirements as described in this document, such person may be denied access by Karoo National Park

## **GENERAL REQUIREMENTS**

- All security guards must have a security clearance and must be registered as required by the Private Security Industry Regulatory Act, Act 57 of 2001 and to have a Grade C level.
- All security staff used at the site must be able to read and write and be able to communicate clearly and efficiently in English.
- A company ID card reflecting *inter alia* the name and training status of a particular individual is to be worn at all times.
- Security guards on duty at the site are expected to be in the complete uniform of the appointed company and must present a neat and clean appearance at all times.
- Guards are expected to present an alert and efficient image to all clients who imply that they may not publicly sit, lounge about, smoke and eat or drink while attending to people.
- Guards shall at all times present a dedicated approach to security and ensure that there are no unnecessary arguments or discourteous behaviour towards both park visitors and staff.
- Guards must be supplied with a cell phone (with paid up airtime) to ensure direct communication at any time with the control room of the service provider.
- Additional equipment provided must include a pocket book and pen as well as a baton/pepper spray and handcuffs.
- Security guards may not be younger than 18 years of age.
- The security service provider will be responsible for the staff complement at the site making sure that site is covered with agreed staff complement at all times.

## **OCCUPATIONAL HEALTH AND SAFETY**

The service provider acknowledges that he is fully aware of the provisions of the OHS Act 85 of 1993 and that he is an employer in his own right with duties and responsibilities as prescribed in the Act.

## **MEETINGS AND/OR REPORTING**

SANParks would require monthly management meetings with the service provider as well as the monthly reports of all occurrences to follow-up of the progress of all identified factors in need of correction or improvement.

## **TERMINATION OF SERVICE**

Aside from the expiry of the agreement, the contract between Karoo National Park (SANParks) and the service provider may be terminated for any one of the following reasons:

- Failure to meet the minimum operational requirements of Karoo National Park (SANParks).
- Gross negligence by the service provider or its employees
- Failure to respond to any operational enquiries or complaints by Karoo National Park (SANParks) within a reasonable time period.

In addition to the above, this agreement may go out of force entirely, at any time, at the discretion of either party on condition that a period of 60 days' notice is given to the other party.

- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;
- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person’s conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.

## GENERAL CONDITIONS OF CONTRACT

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

**South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.**

### 1. Definitions - The following terms shall be interpreted as indicated:

Goods produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. **“Day”** means calendar day.
- 1.8. **“Delivery”** means delivery in compliance of the conditions of the contract or order.
- 1.9. **“Delivery ex stock”** means immediate delivery directly from stock actually on hand.
- 1.10. **“Delivery into consignees store or to his site”** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies

	are so delivered and a valid receipt is obtained.
1.11.	" <b>Dumping</b> " occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
