1. PURPOSE

The purpose of this RFQ is to invite an accredited Electrical Contractor to conduct a site assessment, propose a suitable solution with a quotation for the supply, delivery and installation of Hybrid Inverters and lithium batteries for Cape Point Gate and Boulders Penguin Colony (Main and Beach Gates) at Table Mountain National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. COMPULSORY SITE BRIEFING SESSION

The **COMPLUSORY SITE BRIEFING SESSION** will be held as an essential part of this bidding process, as it promotes efficiency, transparency and equality which are important principles in any Supply Chain Management process. The briefing session further affords prospective bidders an opportunity to clearly understand the services required, the environment in which the service will be rendered and the compliance requirements. The briefing session will be conducted at both site; Cape Point Gate and Boulders Penguin Colony (Main and Beach Gates) at Table Mountain National Park.

Bidders who have not attended the compulsory briefing will be disqualified and will not proceed to any evaluation stage.

4. SCOPE OF WORK

SANParks needs an accredited Electrical Contractor to conduct a site assessment for the supply, delivery, and installation of Hybrid inverters and lithium batteries for Cape Point Gate and Boulders Penguin Colony (Main and Beach Gates) at Table Mountain National Park to run as emergency backup power during Loadshedding.

4.1 OTHER REQUIREMENTS

The successful service provider will be required to perform the following:

- a) Provide an assessment from information gathered at the compulsory briefing session and site inspection.
- b) Do site preparation for the installation of the hybrid inverter and lithium batteries system.
- c) Supply and installation of the hybrid inverter and lithium batteries system which includes connection to the DB mains.
- d) Testing and commissioning of the hybrid inverter and lithium batteries system.
- e) Issuing of a Certificate of Compliance for electrical installations / connections performed by a qualified electrician.
- f) Provide onsite training to SANParks employees on the use, operation and maintenance of the system.
- f) Provide to SANParks all user manuals and warranties issued by the manufacturer of the product.

4.2 All costs associated with the supply, installation, commissioning and training of SANParks staff must be included in the bid price and must be VAT inclusive.

4.3 Bidders must, in their response to this request for quotation, include the technical specifications of the products (details of the hybrid inverter and batteries) to SANParks.

4.4 The unit must provide with up to 8-12 hours of uninterrupted power.

4.5 Hybrid system that can be used as a Grid-Tied (charging via municipality power) or Off- Grid (charging via Solar panels).

5. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply which requirements as stipulated below:

- Submission of fully completed SBD 4 (Bidder's disclosure).

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;

4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
