1. PURPOSE

The purpose of these terms of reference (ToR) is to invite bidders to submit a quotation for **Maintenance, Installation, Repair of DSTV Signal & Television for Mountain Zebra National Park** for a period of one (1) year

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

Mountain Zebra National Park intends to appoint a service provider for installation of satellite dish and repair of DSTV and Televisions for a period of one (1) year as and when the need arises.

3.1 Maintenance, Installation & repair of DSTV and supply of spare parts as per below requirements:

- i) Satellite dish installations ; DStv Extra View Connections and decoder testing
- ii) Dstv Dish Relocation;
- iii) Signal Realignment and Satellite Dish Alignment
- iv) Faulty LNB replacements (Single LNB, Twin LNB, and Smart LNB Replacements

- v) Fast DStv no signal troubleshooting, and deducing picture problems
- vi) DStv Repair Services
- vii) Installation additional TV points,

- viii) DStv cable replacements, replace old satellite dishes,

3.2 Maintenance & repair of TV as per below requirements:

- i) TV installation and mounting
- ii) Plasma & repair
- iii) TV wall brackets installation
- iv) Satellite Dish Alignment
- v) Extra TV points connections,
- vi) TV diagnosis, picture problem, sound issues, connectivity problems, power issues, remote control issues, LED TV screen goes blank, no sound output on the TV, lines or cracks on the screen.

4. RESPONSIBILITY OF THE BIDDER

- 4.1 The service provider will be responsible to determine the cause of fault based on the symptom and to effect necessary repairs to maintain original efficiency to acceptable standards
- 4.2 Service provider should have the necessary tools and testing equipment to make sure that the installation is done professionally and accordingly to Multichoice standards
- 4.3 A detail test report must be supplied to the client for any repair work that has been completed
- 4.4 The service provider will be required to maintain and keep a proper record of all the repair work that has been completed
- 4.5 The service provider is required to complete any installation and repairs within 24 hours after a formal request from SANParks
- 4.6 The service provider is expected to specify the turnaround time for installation and repair work

- 4.7 The service provider must be always available on weekends, public holidays and peak season (December holidays)
- 4.8 The service provider must provide top quality advice and guidance and layout of any DSTV, mostly used in hospitality establishments.
- 4.9 Prior to installation or repair, the service provider must issue a formal quotation to the client, a purchase order will be issued by the client thereafter. Upon issue of a Purchase order work must be done within 24 hours.
- 4.10 Any additional work outside of scope must be accompanied by written quotation where the park management will give the go ahead before the work gets done.

5. RESPONSIBILITIES OF THE SANPARKS

- To provide the tendering company with information that will assist in submitting the tender.
- Monitor the performance of the supplier and propose mitigation plan
- Give indication of unsatisfactory performance to the attention of the company's management for improvement and expect feedback on how such unsatisfactory performance or bad behaviour will be prevented for future occurrences.
- Effecting payment within 30 days from date of receipt of original tax invoices

6. SPECIAL CONDITIONS

- General and Special Conditions of Contract The General Conditions of Contract (GCC) available on the National Treasury website
- The scope of work shall form part of a contract
- The service provider may not assign or subcontract any part of the order without the written consent of the SANParks.
- In the event that the service provider fails to render the service, SANParks retains the right to take which ever steps are necessary to alleviate the situation. This may include the involvement of other service providers and the service provider will not have any claim because of the actions taken by SANParks.

- An official order will be issued before any service is rendered to Mountain Zebra National Park.

7. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply which requirements as stipulated below:

1.2 **To be completed by the organ of state**

- a) The applicable preference point system for this tender is the 80/20 preference point system.
- b) The 80/20 preference point system will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will

be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
