INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by excelling in the management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

The Parks under the management of SANParks are divided into 6 regions:

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The Information and Communications Technology (ICT) department of SANParks is responsible for managing and maintaining the organization's technology infrastructure, including hardware, software, networking, and telecommunications systems. These responsibilities are delivered through two operational units which are: Information Technology Operations (IT OPS) and Enterprise Applications Development (EAD).

The IT Operations focuses on the infrastructure components such as the management of networks, servers, security and telecommunications systems. The Enterprise Applications Development unit focuses on the development and management of business systems (Finance, SCM, HCM, ECM, Tourism, e-commerce/website etc.), software quality assurance and technical support.

The appointment of a service provider for the development, maintenance and support of the Microsoft Dynamics GP environment will be managed by the Enterprise Applications Development unit of the ICT department.

CONTEXT OF THIS PROCUREMENT

SANParks utilizes Microsoft Dynamics GP, formerly known as Great Plains, to manage finances and accounting, including accounts payable and receivable, bank reconciliation, and general ledger. The software also allows for the management of inventories, sales orders, purchase orders, and supply chain.

In the 2018/19 fiscal year, SANParks enlisted the services of Sethewo for the maintenance and support of the Microsoft Dynamics GP for a five-year term. With the Sethewo contract ended in August 2023, SANParks is now seeking bids from qualified service providers who possess the necessary capacity to develop, maintain, and support the Microsoft Dynamics GP environment.

CONTRACT PERIOD

The contract will be for a period of **two (02) years**.

SPECIFICATIONS/SCOPE OF WORK

The support partner will be responsible the full development and maintenance life cycle including the design and optimization of existing processes (including all documentation, user interfaces and source code), the migration of historical data and content as and when required.

It is with the above context that SANParks seeks appoint service provider with a proven track record to provide professional services in delivering the following services:

- Providing technical support and guidance to users
- Receiving and responding to user inquiries and support requests in a timely and professional manner.
- Troubleshooting and diagnosing Dynamics problems reported by users.
- Providing technical assistance to user via phone, email etc
- The development of new processes, continued optimization, and maintaining existing processes within the Microsoft Dynamics Environment.
- To provide business process analysis and development services during the execution of the projects.
- To provide process integration/interfacing where applicable with other internal and external systems in a secure manner.
- To improve the source code documentation and reduce/eliminate hard coded processes in the environment.
- To provide 2nd level support to the internal finance support team.
- To provide end-user training as and when required.

RESPONSIBILITIES OF SANPARKS

SANParks shall:

- Give indication of unsatisfactory performance to the attention of the company's management for improvement and expect feedback on how such unsatisfactory performance or bad behaviour will be prevented for future occurrences.
- Review the monthly report and provide feedback.
- Effecting payment within 30 days from date of receipt of original tax invoices.
