1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to invite service providers to conduct an Ethics Management Maturity Assessment.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

During 2019 SANParks was assessed by the Department of Fishery, Forestry and the Environment (DFFE) using the Governance Maturity Framework. The outcome of the assessment indicated that SANParks' achieved an overall level 4 rating ('Entrenched / Institutionalised Deep-rooted') out of the 5-level scale. The governance and management of ethics was one of the nine areas that were assessed. During the assessment, SANParks achieved a level 2 rating for the ethics management section, indicative that ethics management was still at a developmental stage.

SANParks has since implemented an ethics management programme, which includes, amongst others, the following components: ethics risk assessment, strategy and plan, ethics ambassadors, ethics reporting to governance structures, training and awareness.

The objective of this initiative is two-fold, firstly to assess the maturity of the ethics management in line with the DFFE assessment model to determine any changes in the maturity level. Secondly, to conduct a comprehensive ethics management maturity assessment in line with best practice.

3. SCOPE OF WORK

SANParks aims to appoint a suitable, qualified and experienced service provider to conduct an ethics management maturity assessment based on the DFFE assessment model, as well as against best practice models, and to make recommendations that will assist the entity to improve and strengthen the overall ethic management.

The service provider must provide the following:

- Assess and provide an opinion of SANParks' ethics management maturity against the DFFE assessment model. (The DFFE assessment reports will be provided to the successful bidder).
- Conduct the ethics management maturity assessment using a qualitative methodology.
- Analyse the evidence provided and engage key ethics management role players to understand the context of SANParks's ethics management.
- Provide a well-considered and supported maturity indicator.
- Provide an opinion of the organisations' maturity level against the industry best practice.

KEY DELIVERABLES

1. Qualitative ethics management maturity assessment.
2. Full report on the outcome with an indicator of the overall maturity status.

TIMEFRAMES

Two months from the date of issuing the order.

- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

The applicable preference point system for this tender is the **80/20** preference point system.

1.2 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.3 The maximum points for this tender are allocated as follows:

1.4 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.5 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
