1. PURPOSE

The purpose of this RFQ is to appoint a service provider to review the SANParks 2019 to 2024 Communication Strategy and draft a five (05) year Communications Strategy, 2024 – 2029.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision and mission statements. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

South African National Parks (SANParks) is inviting suitable service providers who are experienced facilitators and communication strategists to submit proposals to a review its 2019 to 2024 five-year communications strategy and draft a five-year 2024 to 2029 communications strategy. The facilitator will be required to guide a process of reviewing the current SANParks Communications Strategy with a group of communications managers and professionals to outline content for an integrated Marketing Communications Strategy for the next five years (2024 to 2029).

Deliverables of the successful service provider will includes:

- Design a strategy review process that is informed by SANParks stakeholders' relations and management approach.
- Facilitate a review of the 2019 to 2024 five-year communications strategy.
- Draft an initial outline of the 2024 to 2029 five-year communications strategy.
- Draft the 2024 to 2029 five-year communication strategy.
- Draft a template of annual communication plan that are based on the five-year communication plan.
- Draft the 2024 to 2025 communication plan based on the 2024 to 2029 communication strategy.
- It will be an added advantage for the bidder to have past exposure in the fields of conservation and tourism.

The five (05) year Communication Strategy must be aligned to SANParks' priorities and enable actionable steps that are set against measurable communication objectives. The strategy should also assist the ability to respond to issues (crisis communications and flow), advice on detailed parameters of work, look at various target audience (stakeholder mapping), outline communications objectives and messaging.

**4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
