1. PURPOSE

The purpose of this exercise is to appoint a service provider for the provision of a virtual hybrid live streaming event for the Vision 2024 launch on 28 July 2024, at **Maslow, Sandton, from 11H00-13H00.**

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of the transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

During 2023 and the early stages of 2024, SANParks engaged in a collaborative, inclusive process to re-imagine and co-create a new future for conservation in and through national protected areas, National Parks, and the National Conservation Agency of 2040, through a Board-led project termed Vision 2040. The project employed the services of specialist Futurists and Strategists to co-create various scenarios and for the SANParks Board to determine and agree on the most desired future. This is "Vision 2040". The preferred scenario has been translated into measurable and reportable outcomes to demonstrate the realisation of the Vision.

3. SCOPE OF WORK

The online platform provider must provide a holistic service that integrates various platforms, working together with venue tech teams. The event will be a hybrid event in nature, having both online and in-person delegates. We expect a total attendance of 500 delegates. In-person attending will be about 40 delegates and the rest will join in virtually.

Venue: Sandton

Time: from 11H00 to 13H00

Venue Design:

VIDEO CAMERAS/LIVE STREAMING

- High-quality video streaming (Zoom) required for live streaming. The digital video equipment should capture the focus of the event, the stage, and the attendees across the five satellite offices.
- The supplier must have capacity to manage live stream broadcast to all five satellite offices Gqeberha, Golden Gate Highlands national park in Freestate Clarens, Cape Town and Garden Route, and have a technician and camera man onsite to manage each of the satellite offices.
- A hybrid system to capture a live broadcast and feed to all five satellite venues in Gqeberha, Golden Gate Highlands national park in Freestate Clarens, Cape Town and Garden Route.
- Web and digital integration – Creation of an event link leading to either a designated event microsite or SANParks hosted landing page.
- Creation of a link to event registration form and managing RSVPs and attendance confirmations.
- An event platform that supports hybrid events with user-friendly and engaging features, with interactive options like polls, raise hand, emojis, Q&A. The platform should have the capacity to support many attendees.
- Three cameras and a vision mixer.

STAGE

- Central stage with a spot for the moderator with digital conference type lectern (that comes with mic) and for presentations by speakers
- Main stage to accommodate number of panellists (10m)
- A stable wired internet connection and readily onsite Tech support.
- Multiple charging stations.
- Bidder must issue Certificate of Compliance

LIGHTING

- Adequate lighting for video production and room ambient lighting. Lighting is required on the stage, as well as on the participants and whatever different set of stage lights, spotlights, colour effects needed.

SOUND SYSTEM

- Professional sound system to cater for 80 number in person attending. Including the 4X headsets microphones for panellists, x4 handheld microphones, X4 roving microphone and digital podium and its microphone.
- Sound technician

SCREENS/PROJECTORS

- Interactive board (white screen board, screen, PC)
- Digital audio-visual projector
- 1x 6mx3m Centre screen
- 2x 3mx2m Side screens

CREW/OPERATORS

- Crew must include all necessary personnel to provide the services as required, i.e., cameramen, director, sound-operator/technician, stage-builder, lighting technician/operators, riggers, etc.)

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
