1. PURPOSE

The purpose of this bid is invitation to bid for the appointment a company that specialises in team building sessions with the executive committee of South African National Parks (SANParks)

2. BACKGROUND

As a leading conservation authority, South African National Parks (SANParks) is a public entity under the jurisdiction of the Department of Forestry, Fisheries and the Environment (DFFE), where inclusive conservation as opposed to previous policies of exclusion is central to advancing the policies in line with the National Development Framework for Sustainable Development and the National Development Plan. SANParks manages a system of 21 functional national parks in seven of the nine provinces of South Africa with a total area of just over 4 million hectares comprising 67% of the protected areas under state management. The SANParks of today is recognised as a world leader in conservation and protected area management. In the last two decades, seven new national parks have been established, totalling over 800 00hectares, with much of this being in the under-conserved biomes such as the Succulent Karoo and Fynbos and 10 marine protected areas (MPAs), totalling 369 657 ha marine protected biodiversity. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

The National Environmental Management Protected Areas Act mandates SANParks to create destinations for nature-based tourism in a manner that is not harmful to the environment. SANParks generates approximately 80% of its operating budget from its ecotourism business, therefore fulfilment of its conservations mandate is heavily reliant on thriving and sustainable tourism operations.

The South African National Parks is a Schedule 3A Entity in terms of the Public Finance Management Act (PFMA). Section 49 (i) of the Public Finance Management Act 1999 states that every Public Entity must have an Executive Authority which must be accountable for the purposes of the PFMA. Subsection 2 of section 49 of the PFMA further states that if the Public Entity has a Board or a controlling body, that Board or Controlling Body is the Accounting Authority of that entity.

Section 56 (1) of the PFMA then states that the accounting authority of a public entity may in writing, delegate any of its powers to an official in that public entity or instruct an official in that public entity to perform any of the duties assigned to Accounting Authority in terms of the PFMA (in particular duties outlined in section 51). This is consistent with Section 71 (1) of NEMPAA (no. 57 of 2003), which states that when necessary for proper performance of its functions, the Board may delegate any of its powers or assign any of its duties to:

- A Board Member.
- A committee of the Board;
- Or a staff member of the South African National Parks.

Section 57 (a) of the PFMA further outlines the responsibilities of other officials of the Public Entity and these include:

- Ensuring and maintaining a system of financial management and internal control,
- Effective, efficient, economical and transparent use of financial and other resources,
- Implementing a system of internal control to prevent irregular, fruitless and wasteful expenditure,
- Management and safe-guarding of assets and management of liabilities of the public entity,
- Complying with the provisions of the PFMA including any delegations or instructions issued in terms of section 56 (by the Accounting Authority).
- Management and safeguarding of the assets and the management of liabilities within that official's area of responsibility.

As an Executive Management of the organisation, SANParks EXCO is therefore individually and collectively responsible for ensuring implementation of the provisions of the PFMA to the extent applicable, including any delegations issued by the Board in terms of NEMPAA.

The SANParks Executive Committee (EXCO) is a management committee established to provide day to day management of the South African National Parks and to implement the SANParks Strategic Plan and Annual Performance Plan as determined by the Board of SANParks. The Executive Committee Members also implement any other function or duty as delegated by the CEO of SANParks.

The EXCO consists of the following members:

- a. The Chief Executive Officer (Chairperson).
- b. Managing Executives which include - The Chief Financial Officer, the Chief Operating Officer, ME: Parks, ME: Kruger National Park, ME: Conservation Services; ME: Tourism Development and Marketing.
- c. Head: Human Capital Management.
- d. Head: Socio-Economic Transformation.
- e. Head: Corporate Communications

5.1.2 The following Senior Management officials attend EXCO meetings as invitees or during extended EXCO Meetings:

- Head of CEO Office
- The Chief Audit Executive
- The Board Secretary and
- Senior General Manager: Strategy and business performance
- General Manager: Enterprise Risk Management

Effective teamwork is the cornerstone of success in any organization, underscoring the importance of cultivating healthy team dynamics. As teams collaborate to achieve common goals, the role of leaders becomes pivotal in fostering a supportive and inclusive culture. It is the responsibility of leaders to nurture an environment where individuals feel valued, respected, and motivated to contribute their best.

For centuries, people have used drumming to release stress, raise their spirits, enhance clarity and focus, and develop co-operation and community bonds. Group Drumming is an excellent activity for stress release, group bonding, team building and the synchronizing of thought processes. This team building activity also helps to break barriers of race, language, gender and hierarchy within teams. Group awareness and communication are highlighted while spontaneity and laughter are encouraged.

Drumming is beneficial for communication, hand coordination, listening and creating. Creating rhythms together naturally promotes teamwork. A drum circle is a team building activity that is collaborative and interactive experience where participants use percussion instruments to create music together. It builds teamwork, communication, and unity through rhythm and synchronized drumming.

In light of the above, SANParks therefore seeks to appoint a Service Provider to run a drumming team building session for its EXCO, integrated with an Enneagram introduction by another service provider.

2. SCOPE OF WORK

The service provider will be required to do, amongst others, the following:

- Meet with the CEO and Project Team Leader in an opening meeting
- Conduct a drumming session with the SANParks EXCO, integrated with an enneagram introduction conducted by another service provider.
- Write a session report

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
