TERMS OF REFERENCE – APPOINTMENT OF A SERVICE PROVIDER TO CONDUCT FEASIBILITY STUDY FOR ASBESTOS CONTAINING MATERIALS AS PER THE REQUIREMENTS OF THE OHS ACT (ASBESTOS REGULATIONS).

INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our **vision** is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our **mandate** is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

BUSINESS UNIT RESPONSIBLE FOR THE BID

The Occupational Health and Safety (OHS) Unit in the Enterprise Risk Management Department is located in the Chief Operating Officer Division. The OHS Unit is responsible for implementing, documenting, maintaining, monitoring, and measuring of the Safety, Health, and Environment Management system by the requirements of the Occupational Health and Safety Act 85 of 1993 and applicable standards

CONTEXT OF THIS PROCUREMENT

SANParks seeks to appoint a suitable qualified panel of service providers to perform Asbestos assessments as per the requirements of the Occupational Health and Safety Act 85 of 1993 and the Asbestos Abatement Regulations, 2022.

CONTRACT PERIOD

The contract with the panel of service providers will run for a period of two (2) years. The successful bidders will form part of the panel. Request for quotations will be issued to the service providers on the panel who will compete on the basis of price, specific goals and any other evaluation criteria applicable for the specific RFQ

SPECIFICATIONS/SCOPE OF WORK

Deliverables

The service provider must have the relevant knowledge, training, and experience to:

- Identify all asbestos-containing materials in, at, or around the workplace, within South African National Parks, and include such in an asbestos inventory:
- Conduct an asbestos risk assessment for quantification of asbestos-containing components in volumes and the types of asbestos and further conduct the laboratory analysis on the type of asbestos found.
- The risk assessment is to be in the context of employee safety and categorized in a hierarchy from high, medium, and low.

- Ensure that the inventory and risk assessment are authorised by an approved asbestos inspection authority.
- Develop a written asbestos management plan including a policy/plan on the total phasing out (remediation and rehabilitation) of all asbestos-containing materials and the cost estimates / implications.
- Asbestos risk mitigation strategies/plans in line with findings, exposure levels, and the quantification of the cost estimates / implications and plan to meet compliance.
- Financial implications of any methodologies for technology, technical and engineering proposal for treatment facilities, and continuous maintenance.
- Provide/ draft a mitigation plan (Scope of work) for the execution phase of mitigation actions of asbestos-containing material.
- Quantify the cost for the entire scope of execution for the treatment and or *removal of each identified exposure source in buildings.*

Requirements for the Service Provider:

- Conduct a risk assessment to determine the classification of asbestos-containing material. (i.e. blue, white, or brown asbestos, etc)
- Subsequently when the quantification and classification assessment is completed to define the type of asbestos-containing material. (i.e., Type 1, 2, or 3) to be undertaken during the remedial work.
- Develop feasible and cost-effective asbestos mitigation options and plans for each identified asset including prices for disposal of asbestos waste at registered hazardous landfill sites and estimate the total financial implications.
- The assessments are to be conducted in line with but not limited to the applicable health and safety and environmental legislative requirements and standards.
- Detail the conclusion and recommendations based on classification and type of asbestos work.

Requirements of the report per region detailed:

- Asbestos-containing material inventory of buildings structures or land containing asbestos material,
- A report outlining the findings, mitigation rehabilitation, and remedial plans.
- Estimated required Budget/Cost for the remediation, rehabilitation, and mitigation plans.
- Conclusion and recommendations based on classification and type of asbestos work.
