**INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our mission is to develop, expand, manage and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

The Parks under the management of SANParks are divided into 6 regions:

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

#### **BUSINESS UNIT RESPONSIBLE FOR THE BID**

Business Development Unit (BDU). The BDU falls under the Managing Executive: Tourism Development and Marketing.

## CONTEXT OF THIS PROCUREMENT

The purpose of this Request for Bid is to contract with a suitably qualified service provider with the requisite capacity to execute this project with the desired quality and within the scope, timeframe and cost for SANParks. SANParks seeks to appoint a suitable service provider to do an assessment of possible funding models linked to user rights. The funding models could include the provision of capital for existing or new assets/products as relevant in exchange for user rights (in relation to, e.g accommodation, trails, events, activities, maintenance etc.) or integration with existing tourism models such as point's schemes or fractional ownership models. However, they must be in line with legislation, i.e. no full-title ownership in National Parks. The service provider will be required to clearly outline what SANParks will be allowed to do in terms of SCM policies and processes (including the award of rights – fair and transparent), ensure that the models proposed are in line with legislation and ensure that models proposed are feasible hence a feasibility model with conditions attached will be required per model.

User rights could include the following but are not limited to:

- Right to book early, i.e., 12 months in advance as opposed to 11 months.
- Rights to use accommodation and / or activities (or a combination) for a specified period (as determined through feasibility studies);
- Rights to on-sell the right, i.e., unit nights per year, but might require that the donor / investor increase the offering of the product. Rules for this to be determined as to prevent negative exposure, which could reflect poorly on SANParks;
- Marketing / branding exposure might include marketing on 'SANParks' website, signage, interpretation material, access via newsletters to the Wild database or association with a product (branding of Kudu emblem allowed on the donor / investors product) or specie, i.e. a rhino, or with communities surrounding the park;
- The adoption of a product, species, community or project in order to promote brand association and benefits;
- CSI points – including carbon trading linked to the value of the SANParks green brand.

The service provider will be required to develop a report within a 6-month period that outlines the different user rights models with associated financial calculations and projections over the full proposed term and should include a presentation file that will be used to present to the SANParks Executive Committee for approval.

In order to compile the report, the service provider will be required to have meetings with a list of critical staff members, visit parks, undertake due diligence on previous models (advantages and disadvantages), verify figures and get an understanding of possible interest from the private sector / investors / donors.

The proposed models should align with current SANParks Policies and applicable guidelines. Where policies do not exist, then policy development may be proposed.

The models need to be founded on sound financial, investment and target market considerations from a SANParks perspective to inform future decisions, reflecting a well-calculated and projected User Right / Donor business model and ratios thereof. A clear proposal of a preferred model needs to be provided and substantiated.

The process needs to be transparent about who can access the opportunity, why and how SANParks needs to implement it, and it should be in line with current legislation and transformation imperatives.

Proposed models need to factor in various financial drivers, including annual price increases, inflation, and the SANParks product operating costs (in relation to accommodation, activities etc.).

## **SPECIFICATIONS/SCOPE OF WORK**

The service provider must outline user rights models that SANParks could implement to provide much-needed capital or assets to SANParks used to improve tourism service delivery.

SANParks implemented a donor model 30 years ago whereby the investors / donors-built units for SANParks to sell but gave them the right to use for 30-40 nights per year for 30 years. At annual occupancy levels of 80%, such units were sold for 292 nights per year minus the 30 as allowed per contract hence 262 nights per year. The user rights model aims to build on such a model but should be more extensive (financing strategy including, e.g., mapping of potential investor/donor profiles in response to desired user rights) and should include the provision of capital injection to address SANParks' needs in relation to existing and earmarked new assets in exchange for rights or allow for low occupancy camps/activities to form part of holiday point schemes (as an example).

It is important that the SCM process that identifies such donors / investors / contributors should be fair, transparent and subscribe to SANParks' transformation objectives. The models should not transgress any legislation and should be viable and beneficial to both parties, specifically, to SANParks. In addition, Models should incorporate a Monitoring and Evaluation (M&E) Framework to ensure sustainability throughout a User Right contractual agreement.

The bidder should cover a wide range of models and solutions. In addition, the following must be considered:

Sourcing of capital in year one (1) that could span contract period with Capex being staggered (viability and feasibility to be determined), focus on maintenance of assets, i.e., negotiated user rights with Facilities Management companies who agree to manage a rest camp / road/conference centre at the industry standards, etc. User rights in this instance could include naming rights, i.e., naming a camp to "Lower Sabie Bidvest, in exchange for maintaining the 60-odd units to 3-star standard for five years.
