1. PURPOSE

The purpose of this RFQ is to invite a supplier/operator to quote for a rental of Business Premises (**Curio Shop at the Cape Agulhas Lighthouse Precinct**) in the **Agulhas National Park for 5 years**.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

The Agulhas National Park (ANP) is one of 22 National Parks managed by South African National Parks (SANParks). The protected area consists of several iconic tourist destinations, including the **Cape Agulhas Lighthouse Precinct and Southernmost Tip of Africa**, and receives over 100 000 per annum across the Park. These visitor numbers create a platform for business opportunities in the Agulhas area.

SANParks, as a parastatal (organ of state), wishes to promote entrepreneurship and support of SMMEs as a driver of the local economy. To this end, ANP wishes to invite prospective commercial operators and traders to quote on the Rental of Business Premises for commercial purposes.

The location of the Business Premises for rent is confined to the ANP's **Cape Agulhas Lighthouse Precinct (GPS Coordinates: Longitude: 20° 00'.6' E Latitude: 34° 49.08' S)**.

In terms of the Park Management Plan, ANP makes provision for a Tourism Product Development Framework. This details a guideline to inform the development potential of the Park. Identified opportunities remain subject to comprehensive feasibility studies and applicable permitting requirements prior to implementation. Therefore, listing an activity does not automatically result in development or implementation.

The opportunities identified for the site include:

Curio Shop – gifts, handmade crafts, branded T-shirts, etc.

The shop area is approximately 38m² with a storeroom of approximately 9m².

Should be in line with the SANParks image.

SANParks will only consider applications that fall within the listed activities. The trading site has a pre-determined location and footprint (extent) from which the trader may not deviate from.

The trader must include in their submission:

- Full description of the proposed business operation to take place on site;
- Price quoted for the site tendered.
- All SBD documentation included in this bid.
- Valid Tax Clearance documentation.
- Valid CSD Compliance Report
- Public Liability Insurance

The bidder will be expected to sign a rental contract with SANParks.

Utilities (Water, Sewerage and Electricity) will be charged as extra and successful bidder will receive monthly billing.

Information provided by the Service Provider in the Quotation shall constitute a binding offer to the ANP that shall form part of any subsequent contract between the parties.

SANParks recommends the bidder who has quoted on the item as required in terms of the RFQ for the contract award, subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions and requirements of the RFQ.

- 3.5 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

(a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
