1. PURPOSE

The purpose of this exercise is to appoint a service provider for the maintenance and repairs on generators included alternators for a period of three (03) years. This service will be rendered for two (2) National Parks in the Western Cape region, Tankwa Karoo National Park, and Bontebok National Park.

Any reference to brand names means similar or equivalent.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

- SANParks needs the service of a service provider to quote on servicing generators and alternators for a period of 36months (3Years).
- Any reference to brand names means similar or equivalent.

The following will be covered under the contract.

Service and repair of all generators as requested.

Emergency repairs on all generators on request.

Service provider should be able to supply or repair parts as needed at reasonable prices.

Service interval on generators is 500hrs.

Supplier to submit full report on generator serviced.

Reasonable traveling rates should be included on the pricing schedule.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;

4. POINTS AWARDED FOR SPECIFIC GOALS
