The existing infrastructure is the first generation Icom Digital Advance System (IDAS) consisting of twenty-two (22) high sites. In total, there are 22 repeaters and more than 400 radios from all around 22 sites. Due to the nature of business operation, the sites are interlinked for the data to be broadcasted across. These are interlinked with Mikrotik and ubiquity microwave systems.

The system was built approximately 10 years ago, therefore KNP requires the service provider to be able to integrate the existing system to the proposed network upgrade to improve the operational of the existing infrastructure.

SPECIFICATIONS/SCOPE OF WORK
