1. PURPOSE

The purpose of this RFQ is to appoint an accredited and competent training service provider to conduct Occupational Health and Safety Training employees of Kruger National Park. The purpose of this training is to have fully functional health and safety officers.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks seeks to appoint a service provider to conduct Occupational Health and Safety Training focusing on:

3.1 Health & Safety Representative, First Aid and Incident Investigation for 564 employees

4. RESPONSIBILITIES OF THE TRAINING PROVIDER

- Deliver the training as per scope of work
- Provide Learner guidance and support.
- Provide Certificates of Competence and statement of Results.
- Training content must be provided as determined by the RFQ.
- Learner statement of results and certificates of competency must be submitted to SANParks.
- Provide completed/signed Training Attendance Register
- Provide Preliminary Training Report (inclusive of the evaluation report, original attached evaluation forms)

5. RESPONSIBILITIES OF SANParks

- Provide a suitable venue for training
- Ensure that employees attend the training.

6. LOCATION OF THE TRAINING

- Training must be conducted at Kruger National Park, Skukuza and Mopani Rest Camps.

7. EXPECTED OUTPUTS AND OUTCOMES

The service provider should:

- produce a Programme framework and indicate, at a high level, the activities of the Programme.
- assess the learners against the relevant unit standards.
- provide certificates of competence to delegates

8. PARTICIPANTS

The total number of staff members to be trained is as follows:

8.1 Health & Safety Representative, First Aid and Incident Investigation for 564 employees

9. APPROACH

- The professional service provider is expected to utilise an approach/ methodology to the programme that will provide theoretical and practical training.

10. PERIOD AND DURATION

- The service provider must confirm completion of the training within the stated timeframe/schedule -dates as requested by SANParks.
- Training duration should be in line with regulation per unit standard.

11. MANDATORY REQUIREMENTS

All mandatory documentation must be submitted by the bidder together with the RFQ Terms of Reference response at the closing date and time of the RFQ. Failure to comply with the mandatory requirements will lead to the bidder being disqualified and not considered for further evaluation. The following proof documentation is required:

- 11.1 The Service provider must provide evidence of relevant qualifications and CV – certificates will be required.
- 11.2 The Service Provider must provide proof of Accreditation with relevant Qualifications Authority (SETA, QCTO Etc.). A letter of Accreditation must indicate details of the unit standard.
- 11.3 Valid Registration with any of one of the following OHS professional bodies: South African Institute of Occupational Safety and Health (SAIOSH) or SACPCMP (South African Council for the Project and Construction Management Profession)
- 11.4 The service provider must confirm the training experience of the instructor/s to be used for the course and provide the assessor certificates and SETA registration.

12. PRICING SCHEDULE

- Bidders are required to provide a detailed and comprehensive price proposal i.e. all costs associated with the bidder's proposal must be clearly specified in their written quotation i.e. travel and subsistence costs, learning material. **NB: SANParks will consider AA related rates for km charge.** SANParks will cover accommodation for training instructors and provide lunch meals for the training.

- All prices quoted must be inclusive of Value Added Tax (VAT). Prices must be presented in South African Rand (ZAR). The Bidders pricing is to remain firm for 90 days from the closing date of this RFQ. SANParks reserves the right to negotiate with the recommended bidder prior to appointment or signing of the contract if applicable.

13. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply with the requirements as stipulated below:

15. CENTRAL SUPPLIER DATABASE INFORMATION

16. EVALUATION CRITERIA AND WEIGHTING

Responses to the RFQ will be evaluated in two phases, i.e.

16.1 Mandatory Evaluation

- The bidder must meet all the mandatory requirements as listed in **paragraph 11**. Failure to comply with the mandatory requirements the bidder will be disqualified and not considered for further evaluation.

16.2 Price Evaluation

- 80/20 preference point system will be applicable as the acquisition of goods and services is estimated to be less than the Rand value of R50 million.

Upon appointment the recommended service provider may be expected to confirm that they will provide the service on the stipulated dates upon receiving a Purchase Order, failure to adhere to the above, SANParks reserve the right to cancel the issued Purchase Order.

Payment will be made in accordance to the PFMA (within 30 days of receipt of invoice) after delivery of service rendered or goods delivered.

20. FINAL AWARD

SANParks recommends the bidder who has quoted on all the items as required in terms of the RFQ for the contract award subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions as requirements of the RFQ.

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1 POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
