1. PURPOSE

The purpose of this RFQ is to appoint a supplier for the Servicing of Outboard Engines, Seastar Steering Helm, Supply and Fit new motor engine and supply and Fit counter rotating propellers.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks needs to appoint a supplier for the servicing of Outboard Engines, Seastar steering helm, Supply and Fit new TRIM motor and Supply and Fit counter rotating propellers.

3.1 SERVICE OF OUTBOARD ENGINES:

100 HOUR SERVICE ON TWO (2) X YAMAHA F200BET OUTBOARD ENGINES

3.2 SERVICE SEASTAR STEERING HELM

3.3 SUPPLY AND FIT ONE (1) NEW TRIM MOTOR ON PORT ENGINE

3.4 SUPPLY AND FIT TWO (2) 14¹/₂ x 19-T COUNTER ROTATING PROPELLORS

Servicing of engines must include change of plugs, oil (engine and gearbox), impellers and Labour.

Bidders must note that wherever this document refers to any particular trade mark, name, patent, design, type, specific origin or producer, such reference shall be deemed to be accompanied by the words "or equivalent.

All prices offered must include all expenses, disbursements and costs (e.g. transport, accommodation etc.) that may be required for the execution of the obligations in terms of the Contract, and shall cover the cost of all general risks,

liabilities and obligations set forth or implied in the Contract as well as overhead charges and profit (in the event that the bid is successful). All prices tendered will be final and binding.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
