**INTRODUCTION TO SANPARKS**

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

### **BUSINESS UNIT RESPONSIBLE FOR THE BID**

Conservation Services Division - Veterinary Wildlife Services

### **CONTEXT OF THIS PROCUREMENT**

Veterinary Wildlife Services is responsible for the veterinary work undertaken in all the protected areas managed by SANParks. This work is multifaceted and includes wildlife capture and translocation, coordination of research on wildlife diseases / biology / capture / anaesthesiology etc. and other conservation management interventions as required. The department has bases in two locations, Skukuza (Mpumalanga Province) and Kimberly (Northern Cape Province) and teams based at these two offices are responsible for wildlife capture work across the entire national parks system in South Africa.

Bids are hereby invited from a panel of qualified and experienced of service providers for the supply of darts (remote drug delivery systems) and associated capture equipment to SANParks (VWS) Veterinary Units located in Skukuza and Kimberly.

### **CONTRACT PERIOD**

The contract period commences from the date that both parties sign the contract's signature page. The contract will be for a period of three (03) years.

### **SPECIFICATIONS/SCOPE OF WORK**

Suppliers may submit a proposal for the supply of any or all of the items listed below.

There is no requirement for the supply of dart guns or projectors.

The bidder should indicate, by completing the relevant pricing in the pricing schedule, which drugs they can supply.

A successful bidder does NOT need the capacity to supply the full product listing in the pricing schedule.

**NB: If bidders supply a different type of Darts, they must make sure that the Darts are compatible to SANParks requirements (the listed dart Projectors)**

Prices provided in the pricing schedule will be used only as an indication of what products a bidder is able to supply. SANParks has the right to award this bid in part or in full.

An RFQ will be issued as and when the need arises on a rotation basis depending on the availability of the commodity. In cases whereby the bidders are unable to supply all the requirements, the RFQ may be awarded per line item and availability of products.
