In addition, there are also twenty-two (22) repeaters, and each site has two repeaters and more than 400 radios used by mainly Rangers and other operators in the various Sections across the 2million hectares of KNP. Due to the nature of business operation, the sites are interlinked for the data to be broadcasted across. These are interlinked with Mikrotik and ubiquity microwave systems.

END USER REQUIREMENTS

The current radio network infrastructure (IDAS) is working on a FDMA protocol, KNP requires the existing system to be upgraded to TDMA protocol and that the Service Provider re-use the existing equipment as much as possible.

With the current system and locality of business, there are some areas where dead spots have been identified. The service provider is required to mitigate the dead spot by increasing the suitable infrastructure like (comms trailer, portable repeaters for emergencies) etc this will also improve the coverage. The service provider shall migrate to a system that will operate 100% with a panic alert function and real time tracking and provide the system monitoring.
