## **1. PURPOSE**

The purpose of this RFQ is to appoint a service provider; To develop the Environmental Education and Awareness Toolkit.

## **2. BACKGROUND**

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## **3. SCOPE OF WORK**

The scope of work for a service provider to develop environmental education and awareness toolkit that will facilitate impact assessments by providing resources and guidelines to effectively conduct and understand environmental impact assessment. The service provider must have developed a toolkit before. Service provider must be willing to travel to (6) six Regions one park per region (Kruger National Park, Arid region, Northern Region, Cape Region, Garden Route, and Frontier Region) to gather information for the development of toolkit.

#### **1. The Kids in Parks programme**

An educational initiative that connects children with nature by facilitating outdoor learning experiences in national parks and natural reserves. It aims to foster environmental awareness, appreciation, and stewardship among young students. The programme includes guided tours, hands-on activities, and curriculum-aligned lessons to enhance their understanding of ecology and conservation.

#### **2. Heritage Education Schools Outreach Program**

A program that aims to educate young people, particularly learners, about heritage preservation, protection, and promotion at local and national levels. actively engage educators and learners in learning about South Africa's cultural and natural heritage, including history, traditions, and biodiversity conservation. Participants learn about the challenges facing heritage and explore ways they can contribute to its preservation, fostering a sense of responsibility and pride in heritage stewardship.

#### **3. Walk and Learn on the Wildside**

Aims to support Conservation, Eco-tourism & Hospitality courses that are offered in the different institutions in South Africa.

The primary beneficiaries of the WALOW programme are Grade 10 &11 High school learners who are interested in a career in these fields. Different institutions such as Colleges and Universities are invited to present on their offered courses, admission requirements and possible bursary opportunities and in the end, learners also get an opportunity to visit the stalls for more information.

#### **4. A Snaring Awareness Programme**

An initiative aimed at educating the public about the dangers and impact of animal snaring on wildlife. It seeks to raise awareness about the illegal practice, promote conservation efforts, and encourage community involvement in protecting wildlife. The programme typically includes educational campaigns, workshops, and advocacy for stronger anti-snaring laws.

**5. Rhino Awareness Programme**

An initiative designed to educate the public about the threats faced by rhinos, such as poaching and habitat loss. It aims to promote conservation efforts and raise funds to protect these endangered animals. The programme typically includes educational campaigns, community involvement, and advocacy for stronger wildlife protection laws.

**6. Trees for School Kids**

A sustainable initiative designed to foster collective ownership and meet the high demand for rehabilitating and reforesting woodlands and indigenous forests, as well as beautifying the nation. This project aims to propagate large quantities of indigenous trees, primarily involving learners and local communities in the production process. By adopting a stewardship approach, the project seeks to instill a sense of ownership of each plant species among individuals and households. Indigenous trees will be allocated to specific households, community groups, youth environmental groups, and churches, many of whom are already frequent visitors to our parks.

**7. Environmental Calendar Days**

Are initiatives that focus on raising awareness and promoting action on specific environmental issues on designated days throughout the year. These programmes often involve educational events, community activities, and campaigns aligned with global or national environmental observances. They aim to engage the public and drive positive environmental change by highlighting key issues and encouraging sustainable practices.

**8. Climate Change Adaptation Programs**

Are initiatives designed to help communities and ecosystems adjust to the impacts of climate change. They focus on developing strategies and measures to mitigate adverse effects, enhance resilience, and promote sustainable practices. These programs often include actions such as improving infrastructure, altering land use practices, and increasing public awareness.

- Develop the SANParks portal/tool kit in a period not exceeding 4 weeks
- Hosting of the system on secure servers or internally with in SANParks, with guaranteed back-ups. This should include regular security threats, bridge, upgrade and intervention reports for a fixed term after which a month-to-month arrangement can be applied
- Provision of technical support for 12 months
- Software upgrade and patching
- Provision of enhancement of the system by adding a new module or improving the existing functionalities once every year
- Recommend and plan for storage requirements as an expect
- The system offered must be web-based and easily accessible, linked to the SANParks website
- Added advantage: alerts and notifications of newly uploaded content to registered users relevant to their topic of interest

**1. GENERAL CONDITIONS**

1.1 The following preference point systems are applicable to invitations to tender:

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

**South African National Parks (SANParks) cannot amend the National Treasury's General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.**
