1. PURPOSE

The purpose of these terms of reference (ToR) is to invite or request bidders to submit a quotation for hiring of earthmoving equipment for maintenance of internal gravel roads within the Camdeboo National Park on an ad-hoc basis for a period of two (2) years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

- The service provider shall hire the earthmoving equipment to SANParks on an ad hoc basis for a period of two (2) years.
- The service provider shall maintain all equipment in good working order.
- Normal working hours is from 07h30 – 16h00 from Mondays to Fridays
- All plant hired to SANParks in terms of this agreement shall be provided within a period of 5 working days from receipt of order.
- The service provider shall deliver plant to SANParks fully licensed and ready to operate, and that unit's insurance are in place.
- The plant rental will require the service provider to provide a rental rate that is inclusive of all costs including fuel, operator and supervision.
- Operators and Drivers are to be supplied with their own accommodation. All these costs must be provided for in the plant rates.

- The Service Provider shall be responsible for ensuring that all Earth Moving Equipment is maintained on a regular basis and repaired when necessary.
- The hire will commence once the unit is delivered to the delivery point until it is removed. Hours lost due to breakdowns, absent operators and servicing will not be paid for by SANParks.
- Over the contract period, Plant Agreement and Ad-Hoc pricing may only be varied on a quarterly inflationary increase based on the Consumer Price Index (CPI) relevant to plant hires.

4. PRICING

All rental rates quoted shall include all costs of any nature whatsoever associated with the supply and operation of the equipment except the fuel escalation rates, including:

- WET rates.
- Qualified Operators,
- Fuel, Oil, Lubrication and all Maintenance,
- Any and all travel time, to or from the delivery point,
- Any and all establishment and/or disestablishment costs to or from the delivery point,
- All insurance, license fees, accommodation and all other costs

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
