SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our **vision** is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our **mandate** is the delivery of Conservation Mandate by Excelling in the Management of a National Park System

Our **mission** is to develop, protect, expand, manage, and promote a system of sustainable national parks that represents natural and cultural heritage assets, through innovation, excellence, responsible tourism and just socio-economic benefit for current and future generations.

The Parks under the management of SANParks are divided into 6 regions:

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

## **BUSINESS UNIT RESPONSIBLE FOR THE BID**

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed in Schedule 3 Part A: Public Entities.

The Human Capital Management (HCM) department of SANParks manages and supports the organization in achieving its strategic objectives through its people. The success of SANParks depends largely on its ability to leverage its human capital as a source to create and sustain a competitive advantage.

The appointment of the three service providers for personal verification and reference checks to enable the Human Capital Management department to support all Parks in effectively identifying talent. The service providers will be managed by the Talent Management unit within the HCM department.

## **CONTEXT OF THIS PROCUREMENT**

SANParks currently has a service provider for personal verification and reference checks of which the contract will be expiring at the end of September 2025. The Human Capital Management department has been faced with challenges with the time it takes for one service provider to service all Parks due to the high volume in demand. It is therefore recommended that there be the appointment of the three service providers for personal verification and reference checks.

SANParks is now seeking bids from qualified service provider for personal verification and reference checks who possess the necessary capacity to support the HCM department with the desired quality, scope, timeframe, and cost requirements.

## **CONTRACT PERIOD**

The contract is for a period of three (3) years.

## **TERMS OF REFERENCE – APPOINTMENT OF THREE (3) SERVICE PROVIDERS FOR PERSONAL VERIFICATIONS AND REFERENCE CHECKS FOR THREE (3) YEARS**

### **SPECIFICATIONS / SCOPE OF WORK**

SANParks seeks to procure recruitment services from reputable Service Providers to assist the Human Capital Management department in verifying suitably qualified and skilled temporary and permanent staff as and when required.

The Service Providers will be required to carry out verifications and reference checks in specified allocated National Parks and Administrative Offices, which are spread across 7 Provinces, with some of the parks based in the remote areas.

The Service Providers should indicate a fixed rate that includes VAT for the service for all salary band levels.

#### Detailed Specification

1. The purpose of this tender is to appoint an accredited service provider to assist SANParks with personal credentials verification of all potential candidates for the organisation or employees.
2. The appointed service provider will be required to provide, maintain and operate systems such as biometric fingerprint systems and platforms that capture the required candidate information as part of service delivery within SANParks premises.
3. The service provider must ensure that the system and platform in all Parks must go live within two (2) months of contract start date.
4. The system should provide authenticated information obtained from the relevant statutory bodies and/or tertiary institutions so as to identify fraudulent qualifications.
5. The appointed service providers must provide training on the system and platform to be utilised by the SANParks staff members (estimated +-50 employees).
6. It is with the above context that SANParks seeks to appoint service providers with proven track records to provide professional services.
7. Bidder must provide monthly reports of verifications conducted indicating adherence and compliance with timelines set. The estimated number of vacancies to be verified is 3620 for the period.

If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
	<b>Contracted Party Due Diligence</b> SANParks reserves the right to conduct supply chain due diligence including site visits and inspections at any time during the contract period.
	<b>Jigs, Tools, and Templates, where applicable</b> Unless otherwise agreed, all jigs, tools, templates, and similar equipment necessary for the execution of this contract is property of SANParks, if SANParks has paid for these. On completion or cancellation of the contract, the contractor delivers all SANParks property to SANParks premises, properly marked with the contract and the relevant code number as supplied by SANParks.
	<b>Copyright and Intellectual Property</b> All background intellectual property (existing prior to this contract) invests in and remains the sole property of the contributing party to this contract and/or the contracted discloses the same to SANParks at the commencement of this contract. The contracted supplier grants SANParks a fully paid up, irrevocable, non-exclusive, and transferable licence to use its background intellectual property including the right to sub-licence to third parties in perpetuity and to the extent that SANParks requires for the exploitation of the contract intellectual property and to enable SANParks to obtain the full benefit of the contract intellectual property.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences, or relationships by furnishing of confidential information by either party pursuant to this contract.
