1. PURPOSE

The purpose of this RFQ is to invite a supplier to submit formal written quotation for supply, installation, servicing and maintenance of a CCTV Camera System with number plate recognition for Tankwa Karoo National Park for a period of 2 years

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks needs the supply, delivery and installation of:

3.1 Numberplate recognition CCTV camera system in Tankwa Karoo National Park at the following locations:

- Roodewerf office
- Elandsberg wilderness camp

3.2 Establishing a solar system to provide power at the cameras.

3.3 Establishing an uninterrupted Wi-Fi connection to cameras that are able to transmit photos, operate the camera and for the alarms to be always functional. NB: There is NO CELL PHONE RECEPTION within the Park.

3.4 The receivers must be able to accommodate a total of 7 cameras

3.5 Maintenance and servicing of cameras for 24 months as and when required

3.6 Annual license and Wi-Fi fees for 24 months

3.7 MATERIAL

All material and parts supplied must be the best obtainable for their respective duties and must comply with the respective SABS. Only original parts may be used.

15% Mark – Up fee on all material/ spare parts

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
