INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now-repealed National Parks Act, 57 of 1976 and continues to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003, with the mandate to conserve, protect, control, and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our **vision** is to have a world-class system of sustainable National Parks reconnecting and inspiring society.

Our **mandate** is to deliver of Conservation Mandate by Excelling in the Management of a National Park System

Our **mission** is to develop, expand, manage, and promote a system of sustainable national parks that represents biodiversity and heritage assets, through innovation and best practice for the just and equitable benefit of current and future generations.

The Parks under the management of SANParks are divided into 6 regions:

Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

The Chief Operating Officer (COO) Division is headed by the Chief Operating Officer, who is appointed in line with the provisions of the National Environmental Management: Protected Areas Act, 57 of 2003, and the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999). The division was established to enhance SANParks' governance, strategy, and business efficiency, particularly given that SANParks, as a Schedule 3(a) entity, is not governed by the Companies Act or its associated prescribed officers. In terms of corporate governance and business efficiency, Schedule 3(a) entities align more closely with government departments, adhering to the relevant public sector regulations rather than the corporate governance frameworks typically applied to companies or state-owned enterprises.

In this context, the General Manager: Continuous Improvement and the Policy Coordination Unit (PCU) work in tandem with the COO Division to drive governance improvements, align business processes with regulatory requirements, and ensure that strategic objectives are met efficiently. The PCU is responsible for coordinating and implementing policies that support SANParks' overall mission and compliance with relevant laws. Together, these units help enhance SANParks' operational effectiveness and align its practices with the best governance standards.

CONTEXT OF THIS PROCUREMENT

The Policy Coordination Unit (PCU) coordinates the full Policy Universe of some 160 instruments (strategies, policies, SOPs, frameworks and guidance notes). The Policy Universe may have overlaps, be incomplete or contain outdated policy instruments that no longer align with current legal requirements, operational needs, or strategic goals. As such, a Gap Analysis is required to ensure SANParks' policy instruments are fully aligned with legal requirements, operational needs, and strategic goals. This analysis will help to identify any gaps in legal compliance by ensuring policy instruments are up to date with evolving laws and regulations, and identify discrepancies between existing policy instruments and those that are required for the organisation. It will also highlight areas where operational inefficiencies or overlaps exist, identifying possible areas for

consolidation to allow for streamlined processes and improved effectiveness. Additionally, it will ensure that policies are aligned with SANParks' strategic objectives, supporting its mission and adapting to emerging priorities. The Policy Universe Gap Analysis will enhance governance, operational performance, and strategic alignment, ensuring SANParks remains efficient, compliant, and focused on achieving its long-term goals.

CONTRACT PERIOD

The contract is for a period of 12 Months. The necessary resources must be in place to ensure this deadline is met.

1.1 Objectives

The objective of this assignment is to:

- Conduct a comprehensive gap analysis of SANParks' existing governance frameworks (policies, SOPs, strategies, and related documents) in terms of all applicable laws, regulations and internal accountability requirements.
- Identify gaps, overlaps, and misalignments within these frameworks.
- Provide recommendations for alignment with SANParks' overarching business model and strategic goals, including the Green Book (the Green Book integrates SANParks' various strategies and policies, highlighting its core mission, values, and objectives in alignment with the organization's strategic direction) and the Vision 2040 Strategy.
- Undertake a detailed review and quality assessment of all Human Capital Management (HCM) policy instruments, with recommendations for rewriting where required.
- Conduct a full review of the Delegation of Authority (DoA) Framework to ensure alignment with governance instruments and practical implementation across the organisation.
- Make proposals for revisions and improvement to the Meta Policy and Meta SOP.
- Advise on best practices, including internationally recognised standards such as ISO guidelines to ensure the governance structure adheres to global benchmarks.

1.2 Scope of Work

The service provider will be required to do, amongst others, the following:

1.2.1 Gap Analysis of Existing Governance Frameworks

- Review and assess all current governance instruments (policies, SOPs, strategies, and frameworks) against SANParks' strategic objectives and business model.
- Conduct a detailed gap analysis to identify:
 - Areas of misalignment between governance frameworks and organisational strategy.
 - Gaps in existing policies or procedures, including outdated or missing components.
 - Overlaps and redundancies in governance instruments.
 - Gaps in implementation mechanisms and compliance monitoring.
 - Inconsistencies or inefficiencies in current policy governance practices.
- Assess each instrument's compliance with all relevant local legislation, regulations and applicable international governance standards. Identify misalignments or contradictions between individual governance instruments and the Delegation of Authority Framework.
- Assess all Human Capital Management (HCM) policy instruments for a detailed quality and compliance review as a priority area within the broader framework.

1.2.2. Recommendations for Strategic Alignment

- Provide actionable recommendations for updating existing instruments, especially strategies and policies, to ensure they are aligned with SANParks' mission, vision, and strategic objectives.
- Ensure alignment with SANParks' broader business model, including conservation, tourism, and community engagement goals.
- Review and align all policy instruments with the Delegation of Authority Framework, identifying necessary adjustments to ensure consistency and support effective decision-making authority across the organisation. Prioritise the review and alignment of Human Capital Management (HCM) policy instruments as a key component of the strategic governance framework.
- Advise on the integration of governance frameworks into the organisational structure for effective implementation.

Recommend opportunities for rationalisation or consolidation of governance instruments to reduce duplication and improve efficiency.

1.2.3. Advise on Best Practices and International Standards

- Identify best practices in governance, incorporating relevant global standards and frameworks, including but not limited to ISO standards.
- Assess the relevance and applicability of these standards to SANParks' legal obligations, organisational context, and operational realities—particularly in areas such as Human Capital Management (HCM) and the Delegation of Authority (DoA).
- Advise on the adoption of these standards and frameworks to improve SANParks' governance structures and practices, enhance coherence across instruments, and support compliance and accountability.
- Provide a gap comparison between current SANParks practices and relevant international benchmarks, highlighting areas where international best practices can be adopted.

1.2.4. Update Governance Documents and Frameworks

- Based on the gap analysis and best practice recommendations, advise on an annual revision schedule to revise and update governance documents (policies, SOPs, strategies) setting clear deadlines, responsible parties, and approval pathways.
- Develop a dedicated update plan for Human Capital Management (HCM) policy instruments, including a timetable for detailed rewrites where quality, compliance, or alignment gaps are identified.
- Produce a matrix that cross-references each updated policy instrument or SOP with the Delegation of Authority (DoA) Framework, confirming decision-making accountability and removing any inconsistencies.

- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licenses or relationships by furnishing of confidential information by either party pursuant to this contract.
