## **1. PURPOSE**

The purpose of this Terms of Reference (ToR) is to outline the requirements and conditions for hiring two (2) Transportal Virtual Reality (VR) console for the inaugural Vision 2040 Indaba, taking place from 3 – 5 September 2025 at Running Waters in Gqeberha, Eastern Cape. The VR activation will feature the SANParks-produced Vision 2040 video, branded with SANParks and Vision 2040 identities, to deliver an immersive and engaging experience that brings to life the Indaba's theme of people and nature thriving together. This activation will serve as an innovative storytelling tool to showcase SANParks' long-term strategy, inspire collaboration among diverse stakeholders, and deepen audience understanding of inclusive, community-driven conservation within South Africa's protected areas system.

## **2. BACKGROUND**

The inaugural Vision 2040 Indaba will convene government leaders, community representatives, conservation partners, private sector stakeholders, and youth to advance SANParks' Vision 2040, a long-term strategy to reimagine conservation in South Africa as inclusive, community-driven, and economically empowering. The Indaba will provide a platform for dialogue, collaboration, and commitment toward creating a future where people and nature thrive together.

To enhance engagement and bring Vision 2040's message to life, two (2) Transportal Virtual Reality (VR) console will be used at the event to showcase the SANParks-produced Vision 2040 video in an immersive format. Branded with SANParks and Vision 2040 identities, the VR experience will serve as an innovative storytelling tool, enabling delegates to visualise the strategy's transformative goals, such as Mega Living Landscapes, community benefit-sharing, and integrated biodiversity conservation, within the context of South Africa's protected areas system.

## **3. SCOPE OF WORK**

The service provider will deliver fully managed VR console services using two (2) Transportal VR systems at the inaugural Vision 2040 Indaba, taking place from 3 – 5 September 2025 at Running Waters in Gqeberha, Eastern Cape. Services will include:

- VR Systems: Provision of two Transportal VR consoles, each optimised for displaying the SANParks *Vision 2040* video and supporting brandable,

immersive experiences aligned with the Indaba's theme of "people and nature thriving together."

- Content: Primary focus on the SANParks-provided *Vision 2040* video, formatted for VR playback. SANParks will provide the video.
- Management: Dedicated VR activation manager/s for each headset to guide participants, ensure smooth playback of the *Vision 2040* video, and troubleshoot issues throughout the Indaba.
- Branding: In-VR and physical branding for SANParks and Vision 2040, integrated into the *Vision 2040* video and/or the Transportal system, reinforcing the Indaba's identity. SANParks will provide the logo/s in required format.
- Setup and Strike: Rapid setup of both consoles before the start of the Indaba (2 September 2025) and dismantling at the close of the event (5 September 2025).
- Audience Engagement: Support for screen/projector displays linked to both VR consoles, allowing non-participants to view the VR content, thereby maximising visibility and engagement among Indaba delegates and attendees.
- NB: SANParks is not going to cover the travelling cost, bidders must include the travelling cost on their quotation.

#### **4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)**

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply which requirements as stipulated below:

- Submission of fully completed SBD1 (Invitation to Bid),
- Submission of a quotation on the company letterhead,
- Submission of fully completed SBD 4 (Bidder's disclosure),

## 10. TIMELINES

Upon appointment the recommended service provider is expected to confirm that they will be able to provide catering as per the terms of reference of the RFQ, failure to confirm, SANParks reserve the right to cancel the Purchase Order.

- Setup: Completed on 2 September 2025 at the designated venue (Running Waters), ensuring both Transportal VR consoles are fully operational before the event's opening.
- Event Duration: 3 – 5 September 2025 (3 days of continuous VR activations during the Indaba programme).
- Strike: Dismantling of both consoles completed on 5 September 2025 after event close, minimising disruption to the venue and ensuring all equipment is safely removed.

## 11. FINANCIAL PAYMENT

Payment will be made in accordance with the PFMA (within 30 days of receipt of invoice) after delivery of service rendered or goods delivered.

## 12. FINAL AWARD

SANParks recommends the bidder who has quoted on all the items as required in terms of the RFQ for the contract award subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions and requirements of the RFQ. Final award will be confirmed by issuing a PO.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender.     - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
    - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
    - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
    - (e) forward the matter for criminal prosecution, if deemed necessary.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
