1. PURPOSE

The purpose of this RFQ is to invite suppliers/contractors for the Bathroom renovations at West Coast National Parks.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act,

Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organization is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organization has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks needs to appoint a supplier/contractor for the bathroom renovations at West Coast Nation Park for 9 staff houses

- Remove old Cabinet and Replace with new Cabinet (30mm x 40mm) White, birch wood or equivalent
- Replace old toilet suite with new white porcelain toilet suite
- Remove and replace old flooring with New Grey Matt Porcelain Floor Tile (tile size: 350 x 350mm)
- Remove, supply and install Grey Ceramic wall tile (tile size: 200 x 100mm)
- Supply and Install standard shower inside the existing bath and 1.5m rail, Stainless steel.
- Supply curtains to bathrooms (White curtain)
- Install mirror (500mm x 400mm)
- Painting of bathrooms: White paint (low sheen) x 2 coats.
- Successful service provider, must dispose of all rubble
- Supply and Replace ceiling with PVC ceiling (All houses)
- Replace old standard bath, supply new bath and install shower inside new bath (All houses)

Successful service provider must dispose of all rubble.

Warranty: The warranty for the Supply and Installation of this contract shall remain valid for six (6) months from date of completion.

Bidders are welcomed to do site visits and familiarize themselves with the aspects of the proposed work and services.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
