1. PURPOSE

The purpose of this RFQ is to invite a supplier to submit formal written quotation for the Supply, Refurbishment and Maintenance of the Ballistic Vessel.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks needs to appoint a supplier for the Supply, Refurbishment and Maintenance of the 6.5 Ballistic Vessel:

- 3.1 Remove existing pontoons and replace with new Hypalon as per original fitted pontoons. Navy/Black. Similar or Equivalent to (Hypalon orca866)
- 3.2 Repair and or replace existing 180L Petrol tank of the Ballistic Vessel and refurbishment of the Deck to original state.
- 3.3 Supply and Refurbish Benches hinges and Seats with same cover material and reinforce all seats hinges with corrosion resistant material.
- 3.4 (a) Repair and Maintenance of all components in the Centre Consol. (Steering, gauges, navigation lights, internal light of the consol, Cup holders, Compass, Navigation system and both ignitions) add 1X USB Power Socket, 1x Pin Power Socket
(b) Supply and install new loom in the centre consol.
- 3.5 Supply and install new Navigation system and radio. 1X VHF 115L and 1X VHF Mount + Antena. South African Map.
- 3.6 Supply and install new Navigation lights (portside, starboard side and mass light), Anchor light/Stan light for the Ballistic Vessel.
- 3.7 Supply and fit law enforcement lights, (blue, flashing lights with controls.)
- 3.8 Supply and fit 2 spotlight LED 100watts. All round white light LED 70 watts.
- 3.9 Skeg protector
- 3.10. Supply and fit new scuppers on Ballistic Vessel
- 3.11. Fix all damages to Hull and repaint to original colour or similar.

- 3.12. Dual Bilge pump system.
- 3.13. Supply and install new 2 batteries and box system.
- 3.14. HD Bow Catcher (Convey Belt)
- 3.15 Stainless steel front FWD BOLLARD. Must be higher than the pontoons.
- 3.16. 2x Capsized bottled, all safety equipment required for Category C Vessel.
- 3.17. Supply and install customised storage box Infront of consol.
- 3.18. Rubberise all stainless steel for good gripping to avoid reflectiveness.

ALL COMPONENTS USED MUST BE OF MATERIALS THAT ARE CORROSION RESISTANT.

Flotation certificate and local general safety certificate for the vessel safety equipment must be provided before any payments.

All prices offered must include all expenses, disbursements and costs (e.g. transport, accommodation etc.) that may be required for the execution of the obligations in terms of the Contract, and shall cover the cost of all general risks, liabilities and obligations set forth or implied in the Contract as well as overhead charges and profit (in the event that the bidder is successful). All prices tendered will be final and binding.

Warranty:

The warranty for components and workmanship shall remain valid for minimum six (6) months from date of completion.

Compulsory Site Meeting:

Bidders are required to attend a compulsory site meeting at which they may familiarize with the aspect of the proposed work, service or supply and pose questions.

Bid Submission without attending the compulsory site meeting will be declared non-Responsive.

Mandatory Requirement:

- Valid letter of good standing for Compensation for Occupational Injuries and Diseases Act, 130 of 1993 (COIDA)

Failure to submit/fully fill in the above-mentioned documents will result to disqualification.

4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply with which requirements as stipulated below:

SANParks recommends the bidder who has quoted on all the items as required in terms of the RFQ for the contract award, subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions and requirements of the RFQ.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process.
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct.
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation.
 - (d) recommend that the tenderer or contractor, its shareholders, and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary
