1. PURPOSE

The purpose of this request is for the appointment of a service provider for the establishment of a community nursery for local communities in Joe Gqabi District Municipality.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

INTRODUCTION

Greening initiatives: Healthy ecosystems deliver critical goods and services, such as food and raw materials. People depend on these goods and services for their well-being and livelihoods. According to the findings of the Millennium Ecosystem Assessment, over the past 50 years, humans have changed ecosystems more rapidly and extensively than in any comparable period in human history, largely to meet rapidly growing demands for food, fresh water, timber, fibre and fuel. This has resulted in a substantial and largely irreversible loss in the diversity of life on Earth. While the changes made to ecosystems have contributed to substantial net gains in human well-being and economic development, these gains have been achieved at growing costs in the form of the degradation of many ecosystem services, accelerated change and the exacerbation of poverty for some groups of people. These problems, unless addressed, will substantially diminish the benefits that future generations obtain from ecosystems, which threaten the achievement of the Sustainable Development Goals.

The proposed Grasslands National Park (GNP) is referred to as the park with a difference because it is being established through stewardship with private and communal landowners. The process of getting the communal landowners contracted into the park is long and requires very specific benefits for the identified communities. This process requires partnering with the local communities. The selected communities are within the Joe Gqabi District Municipality, which has over 62% of its population living in poverty. This calls for action from SANParks and landscape partners working in these areas, to not only focus on the conservation targets but also try to address social ills such as poverty. This is very much in line with SANParks Vision 2040 and the Mega Living Landscapes approach that call for inclusive, flexible and

collaborative conservation. One way of doing this is the introduction of community projects such as Agro-ecology Garden project, which has unlocked an opportunity for the establishment of an organic community nursery. These will seek to address environmental challenges as well as the high rates of poverty, high unemployment and the high dependency on social grants.

The community nursery will serve as:

- A learning hub for traditional healers, schools and broader local communities, providing mentorship in the sustainable use of medicinal plants for all users.
- Space to facilitate the propagation of new garden vegetables and fruit trees for agro-processing, supporting local food security.
- Local supplier for seedlings to local communities, promoting sustainable agriculture practices.
- A vehicle for business development and training support for business development in local communities and, ultimately, an operational community-owned SMME.

OBJECTIVES

To engage a qualified service provider to design, establish/ build a community nursery that focuses on medicinal plants, the cultivation of fruit trees and vegetables for sale to local communities, and the capacitation of local communities.

SCOPE OF WORK

The service provider will be responsible for the following:

- **Nursery Construction:** Construct the nursery infrastructure attached as Annexure A including:

1. Plastic Tunnel (5m x 5m)

- **Frame:**
 - Treated pine poles (CCA treated, SABS approved).
 - Minimum 100 mm diameter uprights, treated to Class H4 for ground contact.
- **Plastic Sheeting:**
 - UV-stabilised polyethylene film (150–200 microns).
 - Preferably “EVA” (ethylene-vinyl acetate) type for flexibility and better light diffusion.
 - Minimum 3-year lifespan warranty.
- **Ventilation:**
 - Roll-up side vents with insect netting (40% shade insect net, 0.6–0.8 mm mesh).
 - Manual roll-up system with treated wooden handles
- **Doors:**
 - Double swing doors (wooden frame, covered with UV plastic)

2. Vegetable Shade Tunnel (12m x 8m)

- **Frame:**
 - Treated gum poles (100 mm diameter uprights, H4 treated).
 - Ridge and cross supports: 75 mm poles or galvanised tubing.
 - Anchoring: poles set 600 mm in concrete or compacted soil.
- **Shade Cloth:**
 - 40–50% green knitted HDPE shade cloth (UV-stabilised).
 - Reinforced edging with eyelets every 1 m for rope fastening.
- **Covering & Fixing:**
 - Shade cloth secured with UV-stabilised cable ties.
 - Option for insect mesh sides for pest protection.
- **Flooring & Beds:**
 - Raised beds (20–30 cm high) filled with organic soil mix OR seedling trays on benches.
- **Doors & Access:**
 - 1.5 m wide framed door with insect mesh.

3. Medicinal Plant Shade Tunnel (10m x 5m)

- **Frame:**
 - Same as above: treated poles.
 - Uprights at 2 m spacing, ridge height at 2.5–3 m for airflow.
- **Shade Cloth:**
 - For medicinal plants, use **50–60% black knitted HDPE cloth** (UV-stabilised).
- **Flooring & Beds:**
 - Raised beds (20–30 cm high) filled with organic soil mix OR seedling trays on benches.

Additional Specifications (for all structures)

- **Fasteners:** Galvanised nails, screws, or bolts to prevent rust.
- **Bracing:** Diagonal cross-bracing with wire or tubing for wind resistance.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2 DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
