1. PURPOSE

The purpose of this RFQ is to appoint a service provider for the provision of Business Analytics Solutions for period of Six (06) Months.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

Business intelligence (BI) assists SANParks to analyse data and to deliver actionable information which helps with making informed business decisions.

It also helps the organisation to manage and analyse data through reporting tools as well as by incorporating a combination of analytics as well as data management. It therefore allows for better management of business information.

SANParks requires the professional services of an accredited service provider on an ad-hoc basis to assist with the planning, design, build, deployment, implementation, configuration, integration, creating visualizations, developing dashboards and sharing data, maintenance and support for existing and planned SANParks licensed BI and analytics software solutions, processes and procedures, which may include, but is not limited to:

- Maintain and update the existing extract, transform and load processes which is done mostly by ProfitBase and Microsoft power BI cloud solution. T-SQL queries are used in ProfitBase and the Microsoft power BI cloud solution to extract the data from the different sources.

- Migrate SSRS reports into Insights supported for reports in workspaces that are hosted in Power BI.
- Consolidate, maintain and update all data sources into ProfitBase and maintain the frontend tools which is Microsoft power BI cloud solution which is running in SharePoint online Integrated mode.
- Maintain and make updates to data models and documentation for report parameters and designs for each report
- Maintain and update existing reports and graphics associated with each report on a regular basis.
- Operate the analytics environment with minimal disruption.
- Maintain system documentation in an approved SANParks document repository. This includes report documentation with parameters and designs.
- Maintain the existing functionality of the reports in the production environment.
- Deliver realtime reports on a variety of media and formats that would allow data to be reformatted or exported into other electronic formats including, but not limited to, CSV, PDF and Excel formats.
- Monitor the report production environment to ensure that all reports, including copies, are readable, accurate, and delivered on schedule to their intended recipients.
- Ensure the accuracy of all newly developed reports, including, but not limited to, calculations and completeness of data used as input.
- Limit accessibility to reports and data according to security specifications dictated by SANParks.
- Support interfaces to other internal or external Decision Support Service such as program specific DSS databases and off site DSS databases
- Produce audit trails of all changes in the environment.
- Migrate developed SSRS reports into Power BI.

DELIVERABLES

SANParks currently has more than 525 SSRS reports within the Business Intelligence environment, which are utilized by a user base of over 1000 individuals. The organisation's internal team provides first-level support for these services, with the current contracted service provider offering second-level support. With this approach, SANParks can ensure efficient and effective reporting of operations and deliver reliable insights for the organisation.

The implementation partner will be responsible for the full development and maintenance life cycle including the graphical visualisation, dashboard design and optimization of existing reports (including all documentation, report interfaces and data sources), the migration of historical data and content as and when required.

It is with the above context that SANParks seeks appoint service provider with a proven track record to provide professional services in delivering the following services:

- maintain existing reports within the Business Intelligence environment.
- To provide data analysis and development reports during as an when required by
- To Maintain the data warehouse (including security) in the Business Intelligence environment and schedulers for real time business reporting.
- To maintain interactive dashboards and reports in the Business Intelligence environment
- To provide 1st and 2nd level support to SANParks team and contracted service providers.
- To provide end-user training as and when required.
