**5 CONTRACT PERIOD**

The contract will be for a duration of three (3) years as and when required and the last service provided as and when required.

**6 MEETINGS AND REPORTS**

SANParks would require meetings every six (6) months or as and when required with the service provider and electronic reports.

**7 RESPONSIBILITY OF SANParks**

- Monitor the professional services that SANParks receives from the service provider.
- Bring unsatisfactory performance under the attention of the company’s management for improvement and expect feedback on how such unsatisfactory performance or bad behaviour will be prevented for future occurrences. Continued unsatisfactory performance may lead to termination of the contract
- Review the report received every six (6) months and provide feedback.
- Effecting payment of invoices according to the requirement of the PFMA.

**8 EVALUATION CRITERIA**

The bid shall be evaluated in three phases. The details of the evaluation phases are outlined below:

**8.1 Phase 1: Mandatory Evaluation Criteria**

All mandatory documentation must be submitted by the bidder together with the bid document at the closing date and time of the bid. **South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.**
