Project Team Leader

Project Team Leader – Minimum 5 years' experience in corporate governance and compliance. The service provider's project manager will be responsible for the overall management of the service provider's project team, the achievement of the project objectives and the quality of the work and products produced by the team. The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences, or relationships by furnishing of confidential information by either party pursuant to this contract.
