## 1. PURPOSE

The purpose of this RFQ is to appoint a panel of service providers from different regions for the vaccination and medical treatment of dogs which is in line with relevant legislation and policies in the Kruger National Park.

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks and Kruger NP in particular make extensive use of K9's in its daily operations and K9's continues to be a critical component which is required for Kruger NP to achieve its Biodiversity Conservation and Law Enforcement objectives. Kruger NP makes use of various breeds and currently 51 working K9's reside and are active in the Park. The following are the most critical uses of K9's in Kruger NP:

- Currently Detection, Human-Scent and Apprehension K9's is being used across Kruger NP, fulfilling various roles.
- Human-Scent tracking K9's are essential for the detection, follow-up and apprehension of suspected poachers and almost all arrests in KNP take place with the assistance of a very capable K9 and K9 Handler.
- Detection K9's are placed at the entrance gates to assist with searching vehicles for firearms, ammunition, Elephant ivory, Rhino horn, Pangolin scales etc. and are able to contribute significantly by detecting these items which may be hidden upon entry and by expediting the time it takes to thoroughly search a vehicle at the entrance gates.
- Apprehension K9's are currently focusing on Night Operations and are critical in these operations as they demonstrate the use of less than lethal force and also provide additional assistance to the team working at night.
- The welfare and husbandry of all the Parks K9's are of critical importance, and it is for this reason that Kruger NP requires a suitably qualified and experienced Service Provider to provide these services.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## 3. SCOPE OF WORK

The scope of work entails the appointment of service provider(s) for vaccination and medical treatment of dogs in the Kruger National Park

for the following:

- Issue annual vaccinations to the KNP Canine Unit and support on site record keeping of such vaccinations.
- Attend to any ill health of the canines when brought into the offsite facility and treat as required/necessary.
- Attend to canines brought to the offsite facility as a result of emergency cases (during or after operational hours);
- Supply and issue deworming treatments and tick and flea treatments when required.
- Sterilization of the canines when required.

- General health and condition inspections as and when required.
- Conduct dental, medical or surgical procedures on the canine as required.
- Treatment of wounds including all subsequent treatments of such wounds (nature of wounds would be in the context of canines working in outdoors and dangerous environments.
- Treatment of bone fractures.
- Treatment of snake bites
- Performs minor to complex surgery depending on the nature of the ailment being treated.
- Support and advice service to the canine handlers on care and treatment of the canines
- Provide annual onsite training to all canine handlers working in KNP
- Euthanizes dogs when necessary/required.
- Determination and certification of the identity, health, fitness or soundness (e.g. medical certificate for off sick dog/s).
- Provides preventive care to maintain the health of the dogs.
- Performs diagnostic tests such as X-ray, EKG, ultrasound, blood, urine, and faeces.
- Perform a postmortem on deceased dogs if necessary/required.
- All consumable items involved in treatment is included in the services provided

**SPECIAL CONDITION:**

- Due to the critical nature of the services required, only Service Providers based in Mpumalanga or Limpopo Province will be considered
- The RFQ is intended to appoint a panel of service providers. However, should the submitted responses not meet the stipulated requirements, SANParks reserves the right to appoint a single qualifying bidder or service provider

Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.
- Bidders are required to demonstrate their ability to undertake the required services and provide proof of expertise and resources to provide the required services.
- Bidders are required to score a minimum of **70** points out of a possible **100** to proceed to the second stage/phase of evaluation
- Bid offers that fail to score the required number of points (**70**) for the functional requirements will be eliminated

All quotations will be evaluated in line with the prescribed preferential procurement regulations, including the application of the 80/20 preference point system, as determined by the estimated value of the procurement.

The duration of the appointment cannot be determined in advance and shall be contingent upon the cumulative expenditure against the approved contract ceiling. The appointment will remain valid until the total expenditure reaches **R1,000,000.00 (One Million Rand), inclusive of VAT.**

- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:


