1. PURPOSE

The purpose of this RFQ is to invite a supplier to submit a formal written quotation for the **Supply and Delivery of Electrical Cable for the Technical Services Department at Table Mountain National Park as per spec.**

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organization is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organization has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks needs to appoint a service provider to supply and deliver of Electrical Cable for the Technical Services Department with the following specification.

- 16mm Thick 4 Core 3.3kV Armadac Electrical Cable or similar approved
- 10mm² Thick Bare Copper Earth Wire.

1.4 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.5 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **Tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.
- (b) **Price**” means an amount of money tendered for goods or services and includes all applicable taxes less all unconditional discounts.
