1. PURPOSE

The purpose of this RFQ is to appoint a capable service provider to manage and deliver a high-quality, events service in Cape Town, **22 May 2026**.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*.

Table Mountain National Park is currently being funded by the Agence Française de Développement (AFD), the French Development Agency to implement a number of projects. The programme seeks to enable strategic learning exchange between the leaders of Table Mountain National Park and Reunion Island National Park.

This RFQ is approved by both SANParks and AFD in terms of the Procurement requirements of both institutions, and as such, this body of work is subject to meeting the Procurement requirements of both institutions.

3. SCOPE OF WORK

The organisation seeks to appoint a qualified and experienced service provider to manage and deliver technical services for an integrated hybrid event, including full technical (IT) support, for a bilingual (French and English) seminar to be held in Cape Town on 22 May 2026, at Table Mountain National Park Head Office, Tokai, Tokai Road.

The selected service provider will be working with translation service provider.

The event will include both in-person and virtual participation, requiring seamless integration between physical and online platforms.

The objective is to showcase, through series of presentations from 09h00 – 13h00, 3 years of work and to create an engaging showcase event.

Full setup and delivery of all technical requirements for a hybrid event, including:

- In venue audio-visual systems (microphones, cameras, lighting, projectors, screens)
- Reliable high-speed internet connectivity for seamless streaming (pre-test at venue to determine if existing connectivity will suffice and is reliable)
- Professional Zoom platform integration as the mandatory live streaming platform
- Interpretation solutions (English-French)
- Recording of the proceedings and video submission in suitable quality for editing.

The platform selected for the livestreaming must be suitable for African and French territories access.

Live technical support:

- In venue audio visual management for presenters, including low staging, lighting, and all equipment, including back up systems and support e.g., power outages or internet failure.
- Seamless integrated planning between the physical event and virtual outcomes delivery.
- Platform hosting and session transitions planning and management.
- Risk assessment, management and mitigation including real-time troubleshooting and backup protocols.

Online participant management, including:

- Design and distribution of Zoom links

- Technical support and guidance for remote attendees

4. Deliverables

The service provider will be required to deliver the following:

- A fully operational, hybrid event platform, ensuring seamless participation for both presenters, in-person and virtual attendees
- High-quality audio and visual production, including clear sound, professional video, and stable live streaming for virtual audiences.
- Full event recording submitted in suitable quality for post-event editing for use on social media.
- A functional online registration and participant management system.
- Accurate attendance registers and participation reports.
- Successful integration of bilingual (French/English) interpretation service provider.
- On-site and virtual technical support throughout the 1-day event.

4. ELIGIBILITY CRITERIA

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
